

### I. Introduction

- 1. At its sixty-seventh session in October 2016, the Executive Committee adopted a decision which set out the issues to be examined by the Standing Committee in its programme of work for 2017. This report provides a summary of the implementation of this programme.
- 2. The Standing Committee held three meetings in 2017: in March, June and September. A planning meeting of Executive Committee members in December 2016 established the calendar of meetings and determined the distribution of the agenda items in 2017. This is provided in the work programme contained in annex I.
- 3. A detailed account of the work undertaken at each meeting of the Standing Committee in 2017 is contained in the following documents: the report of the sixty-eighth meeting of the Standing Committee (A/AC.96/1166); the report of the sixty-ninth meeting of the Standing Committee (A/AC.96/1173); and the report of the seventieth meeting of the Standing Committee (A/AC.96/1174). A list of conference room papers, strategic overviews and other documents considered at these meetings is contained in annex II.

# II. Issues considered by the Standing Committee in 2017

### A. Programme budgets and funding

4. At each of its meetings, the Standing Committee considered updates on budgets and funding, through which it was kept informed of programme requirements, budgetary measures and funding levels. The Committee also adopted decisions on budgets and funding, as listed in chapter III below. In June, the Standing Committee was briefed on UNHCR's Global Report on activities in 2016. At its September meeting, the Committee reviewed the biennial programme budget for 2018-2019, as well as an advance version of the Report of the Advisory Committee on Administrative and Budgetary Questions (ACABQ), in relation to the biennial budget.

### **B.** International protection

5. At each of its meetings, the Standing Committee was briefed on developments concerning the Executive Committee conclusions on international protection. In March, the Standing Committee received an oral update on the High Commissioner's Dialogues on Protection Challenges. In June, the Standing Committee discussed the note on international protection; updates on statelessness and resettlement; and a paper on machine-readable travel documents.

#### C. Regional activities and global programmes

6. UNHCR's operations in all five regions (Africa; the Americas; Asia and the Pacific; Europe; and the Middle East and North Africa) were comprehensively discussed at the Standing Committee's meeting in March. The Committee also received updates on global programmes; resilience and self-reliance from a protection and solutions perspective; and emergency preparedness and response. In June, the Committee was presented with reports on cash-based interventions and on the strengthening of humanitarian-development cooperation in forced displacement situations.

### D. Programme/protection policy

7. The June Standing Committee reviewed updates on community-based protection and accountability to affected populations, and on education. It also discussed the global strategic priorities.

# E. Management, financial control, administrative oversight and human resources

- 8. In March, the Standing Committee considered a report on the funding of afterservice health insurance (ASHI) and repatriation benefit liabilities and subsequently adopted a decision on the funding of end-of-service and post-retirement benefits, as listed in chapter III below. The Committee also reviewed a report on follow-up to the recommendations of the Board of Auditors on the financial statements for previous years and received an update on the work of the Inspector General's Office.
- 9. In September, the Committee reviewed the report of the Board of Auditors on UNHCR's financial statements for the year 2016 and discussed the key issues identified in the report and measures taken by UNHCR in response. The United Nations Office of Internal Oversight Services presented its annual report on internal audit activities undertaken at UNHCR for the period 1 July 2016 to 30 June 2017, and the Committee received the annual report of the Independent Audit and Oversight Committee. Updates were also provided on progress toward implementing the "grand bargain" commitments; human resources, including staff welfare; and staff safety and security.

#### F. Coordination

10. At each of its meetings, the Standing Committee was briefed on developments concerning the follow-up to the New York Declaration and the comprehensive refugee response framework.

### G. Governance

11. The Standing Committee adopted the work programme for 2017 in March, as proposed at its December 2016 planning meeting. In June, the Committee was invited to make suggestions on issues to be included in the High Commissioner's opening statement to the sixty-eighth plenary session of the Executive Committee.

# III. Standing Committee decisions

- 12. In accordance with the authority vested in it by the Executive Committee, the Standing Committee adopted the following decisions, which are annexed to the reports of the Standing Committee meetings:
