3.1 Scope and content

The records document the work of the office in Japan, particularly the complex procedures involving the Vietnamese boat people. All stages of the Indochinese refugee problem are reflected in the records, from the drama of the rescues at sea, through the resettlement programs in third countries, the voluntary repatriation effort, and the events following the adoption of the Comprehensive Plan of Action.

The Comprehensive Plan of Action (CPA) was a regional agreement, adopted by Southeast Asians governments in June 1989, to review the status of the Indo-Chinese asylum seekers in their countries and to determine an appropriate "durable solution" for them. Following the screening, most persons were returned to their country of origin. The CPA officially ended at the end of 1997.

The files consist primarily of individual case files. While most of the records are of Indo-Chinese refugees, some series include case files from non-Southeast Asian refugees or refugee groups, enabling the researcher to compare and contrast the procedures in both types of cases.

The records arrived in cartons marked "IC files (old) Indo-Chinese 1-12," "IC files (old) Indo-Chinese Misc," "CPA 1-3," "Old files," and "IC info (old) CPA." The three cartons that were marked "IC info (old) CPA" were the consolidated boat and case files now found as series 3. The other cartons proved to have considerably varied contents. The series by which they are now identified (below) were determined by the filing codes on the files. Many of the series are clearly fragments of larger series, the remainders of which were not transferred to the Archives.
