3.1 Scope and content The records consist of correspondence, reports, memoranda,

speeches, and printed materials. They relate primarily to educational matters or to refugee issues. Much of the correspondence is semi-official, and individual pieces are sometimes marked "1.0 priv. file," indicating that the office staff was filing it but maintaining it separately for Kullmann.

The records are rich in information on various groups located in the United Kingdom, both immediately prior to and during World War II, who worked to assist refugees. A series of files from the Intergovernmental Committee on Refugees, marked with Registry numbers and labelled "Legal Department - Dr. Kullmann's Office," are found in Series 2. Of particular note are the papers relating to missions Kullmann took to Poland in March 1939 (reports on Russian and Czechoslovak refugees), to Portugal in July 1941 (reports on refugee situations in Portugal, unoccupied France, and North Africa), and to Switzerland in February 1944; these are found in Series 4. The papers also contain numerous legal analyses of the status of refugees (see, for example, the file on the "Grotius Society" in Series 4).
