# East and Horn of Africa

## Operational highlights

- UNHCR facilitated the voluntary repatriation of 42,000 Sudanese refugees from Ethiopia, Kenya and Uganda to Southern Sudan in 2007. In addition, a significant number of refugees returned spontaneously to Sudan, although statistics are not yet available.
- In Uganda at the end of 2007, some 579,000 IDPs finally returned to their homes or places of choice, while another 300,000 internally displaced persons (IDPs) started the return movement and are in transit areas. Given the large number of returnees, the Government has developed a comprehensive recovery and development programme primarily targeting conflict-stricken areas in the north of the country.
- It is estimated that up to a million people were displaced in Somalia in 2007, mostly in the southern and central parts of the country. Renewed fighting, scarcity of food and lack of livelihood were the main factors fuelling the humanitarian crisis.
- In Ethiopia, UNHCR registered more than 8,000 new arrivals from Eritrea, more than 70 per cent of them young urban men possibly fleeing military conscription.
- Although the Kenya/Somalia border remained closed; some 18,000 people from south and central Somalia arrived in Dadaab, in north-eastern Kenya.



## Working environment

The East and Horn of Africa region faced ongoing conflict and natural disasters throughout 2007, particularly in Ethiopia, Kenya and Somalia. Fighting continued in south and central Somalia and peace talks between the Government of Uganda and Lords Resistance Army continued at a slow pace.

In Somalia, due to the security constrains UNHCR and its humanitarian partners could not reach most of the IDPs and others in need of protection and assistance, especially in Mogadishu. However, with the support of the African Union (AU) peacekeeping force in Mogadishu, UNHCR's national staff and local partners were able to provide emergency shelter and non-food items to IDPs.

UN peacekeepers withdrew from Eritrea following disagreements over the Government's restrictions on the supply of food and fuel to them. Meanwhile, tension remained high on the border with Ethiopia, with extensive military build-ups on both sides.

# Achievements and impact

In 2007, UNHCR ran special projects to prevent and treat malnutrition and malaria and improve health services in the subregion. As a result, acute malnutrition


among the camp-based Somali refugees in Kenya was reduced from 22 to 12 per cent; among Sudanese refugees it decreased from 16 to 9 per cent. The new projects also strengthened early warning, surveillance and health information systems.

In Djibouti, a Tripartite Repatriation Agreement between the Government of Djibouti, the *Somaliland* authorities and UNHCR paved the way for the voluntary return of some 1,800 refugees to *Somaliland*. UNHCR supervised and facilitated the operation, and provided the returnees with reintegration assistance packages.

Following the enactment of the Refugee Act, the Government of Kenya appointed a Commissioner to lead the newly established Department of Refugee Affairs and act as UNHCR's main national counterpart in Kenya.

In Uganda, UNHCR began training of government officials to strengthen their capacity to manage refugee protection and assistance activities.

In central Somalia, UNHCR established an international presence in Galkacyo, the provincial capital of the Mudug region, *Puntland,* to improve its ability to monitor protection and provide assistance to some 100,000 IDPs.



#### Constraints

The deteriorating political and security situation was a major hindrance to humanitarian operations in south and central Somalia. Armed conflicts made it extremely difficult to monitor protection and assistance of IDPs in most parts of the country.

Programmes for protracted refugee situations in the subregion faced funding constraints which made it difficult to maintain minimum standards of assistance. Self-reliance and livelihood support programmes were significantly reduced on 2007.

In Puntland, irregular and mixed migratory movements, and the human trafficking of individuals from Ethiopia and Somalia created protection challenges for those seeking to cross the Gulf of Aden.

## **Operations**

UNHCR operations in Ethiopia, Kenya, Somalia and **Uganda** are described in separate chapters.

While repatriation was a priority for countries hosting refugees in 2007, the rehabilitation of refugee-impacted and hosting areas also became a priority. Governments and communities have demanded that UNHCR rehabilitate refugee sites, clean-up and redress environmental damage and renovate local infrastructure prior to handing them over for community use.

#### The Regional Support Hub (RSH)

The Regional Support Hub in Nairobi provided technical support to some 12 countries in the East and Horn of Africa and the Great Lakes region. Functional units supported programmes covering registration, resettlement, HIV and AIDS prevention, public health, staff safety, supply chain management and women and children. It also represented UNHCR in various subregional humanitarian forums in Nairobi.

The regional hub was supported by 26 international staff, 19 national staff and four experts from the International Catholic Migration Commission. Regional officers aligned their work with the priorities of countries in the region. Overall, UNHCR focused on strengthening the inter-agency response to IDP protection, emergency shelter, and camp coordination and camp management by participating in inter-agency cluster meetings and harmonizing data.

#### The African Union Liaison Unit in Addis Ababa

UNHCR worked closely with the AU, the Inter-Governmental Agency for Development (IGAD), and governing bodies of the African Development Bank and the Economic Commission for Africa. The Office engaged with member States to ensure that critical issues concerning refugees, returnees and IDPs were addressed at policy meetings. UNHCR also facilitated visits by AU officials to refugee and IDP camps in the subregion. The Regional Liaison Representative in Addis Ababa was UNHCR's main interlocutor with the AU.

The Office helped the AU prepare for its Convention on Internally Displaced Persons, which has the potential to be as significant as the 1969 OAU Refugee Convention. UNHCR offered technical support and advice during the drafting process. UNHCR also assisted the AU to set up mechanisms to implement the AU Policy Framework on Post Conflict Reconstruction and Development. The Framework is designed to help countries emerging from conflict by


consolidating peace, supporting reconstruction and enhancing coordination between humanitarian actors. UNHCR also helped the AU prepare for its first Special Summit on Refugees, Returnees and IDPs, which will take place in November 2008.

### Financial information

The year 2007 saw increases of the approved budget, due mainly to emergencies arising from the Somalia situation and the allocation of additional funds to address sexual and gender-based violence, malnutrition and malaria. Funds were reallocated throughout the sub-region to maintain essential services for refugees.

UNHCR's expenditure in the East and Horn of Africa (excluding the Sudan programme) rose from USD 87 million in 2002 to USD 142 million in 2007. The largest proportion of expenditure went towards health care, education and programme support. Supplementary appropriations supported UNHCR's

greater engagement with IDPs, particularly in Uganda and Somalia.
