## Report on the Work of the Standing Committee

### I. INTRODUCTION

1. At its fifty-ninth session in October 2008, the Executive Committee adopted a decision which set out the issues to be examined by the Standing Committee in its programme of work for 2009.<sup>1</sup> This report provides a summary of the implementation of this programme.

2. The Standing Committee held three meetings in 2009: in March, June and September. A planning meeting of Executive Committee members in December 2008 established the calendar of meetings and determined the distribution of the different agenda items in 2009. This is provided in Annex I.

3. A detailed account of the work undertaken at each of the meetings of the Standing Committee in 2009 is contained in the following reports: *Report of the forty-fourth meeting of the Standing Committee* (A/AC.96/1065); *Report of the forty-fifth meeting of the Standing Committee* (A/AC.96/1073); and *Report of the forty-sixth meeting of the Standing Committee* (A/AC.96/1074). A list of documents relating to these meetings is provided in Annex II.

#### II. ISSUES COVERED BY THE STANDING COMMITTEE IN 2009

#### A. Programme budgets and funding

4. At each of its meetings, the Standing Committee considered updates on overall programme budgets and funding through which it was kept informed of programme requirements, budgetary measures and funding levels. The Committee also adopted decisions, as listed in section III below. At the June meeting, the Committee also considered the Global Report on UNHCR's activities in 2008. In its September meeting, the Standing Committee reviewed the Biennial Programme Budget for 2010 and 2011 in the new budget structure, and discussed a proposal for an increase to the 2009 appropriation level of the "New or additional activities – mandate-related" Reserve, as well as proposals for a revision of the Financial Rules. In September, the Committee also discussed UNHCR's resource mobilization strategy, including private sector fund raising.

#### B. International Protection

5. In March, the Standing Committee received an oral update on the second meeting of the High Commissioner's Dialogue on Protection Challenges that had taken place in December 2008. The June meeting included a debate on the Note on International Protection and a progress report on Statelessness. The Committee also received an update on implementation of the Agenda for Protection.

#### C. Regional activities and global programmes

6. Regional reviews of UNHCR's programmes and activities in all five regions: Africa; the Americas; Asia and the Pacific; the Middle East and North Africa; and Europe, were considered comprehensively at the Standing Committee's meeting in March. In addition to the regional reviews, the Committee also discussed the Office's global programmes and partnerships. The Committee also received a report on UNHCR's supply chain management in March and a report on staff safety and security issues, including refugee security in June.

#### D. <u>Programme/Protection policy</u>

7. At the March meeting, the Committee received a presentation on UNHCR's policy framework and implementation strategy on its role in support of the return and reintegration of displaced populations, as well as a briefing on the implementation and mainstreaming of the global workplan for IDP operations. In June, the Standing Committee discussed reports on the protection of women and girls in displacement, as well as on environmental issues. A decision on the latter was adopted at the June meeting.

#### E. Coordination

8. The Committee considered elements for UNHCR's oral update to the 2009 substantive session of the Economic and Social Council at its June meeting. An update on inter-agency coordination issues and strategic partnerships was discussed in the September meeting.

#### F. Management, financial control, administrative oversight and human resources

9. At each meeting, the Standing Committee received an update on UNHCR's structural and management change process. In March, the Committee received reports on follow-up measures taken in response to recommendations in the Report of the Board of Auditors for 2007, and on the work of the Inspector General's Office. In June, the Committee was also apprised of progress with the introduction of International Public Sector Accounting Standards (IPSAS) and with strategies envisaged for funding end-of-service and post-retirement benefits.

10. In September, the Standing Committee received a report on the Ethics Office and an update on UNHCR's policy for achieving gender equity in its staffing. The September meeting also considered the Report of the Board of Auditors on UNHCR's accounts for 2008, and discussed measures taken or proposed in response to recommendations in the Report of the Board of Auditors for 2008 and previous years. Also in September, the Office of Internal Oversight Services presented its annual report on internal audit activities undertaken at UNHCR for the period 1 July 2008 to 30 June 2009.

#### G. Governance

11. In March, the Standing Committee adopted the work programme for 2009 as proposed at its December 2008 planning meeting. In June, under governance issues, the Committee called on delegations to provide suggestions for issues to be included in the High Commissioner's opening statement at the sixtieth session of the Executive Committee.

#### H. Consultations

12. In accordance with its standard practice, the Standing Committee held informal consultative meetings in the course of the year on issues requiring in-depth discussion. These included a briefing on the Policy Development and Evaluation Service's workplan for 2009; two meetings on the Global Needs Assessment (GNA) and on GNA prioritization; and two meetings on UNHCR's Biennial Programme Budget for 2010-2011.

#### III. STANDING COMMITTEE DECISIONS

13. In accordance with the authority vested in it by the Executive Committee, the Standing Committee adopted a number of decisions which are annexed to the reports of the different Standing Committee meetings, as follows:
