### I. Introduction

1. At its sixtieth session in October 2009, the Executive Committee adopted a decision which set out the issues to be examined by the Standing Committee in its programme of work for 2010.<sup>1</sup> This report provides a summary of the implementation of this programme.

2. The Standing Committee held three meetings in 2010: in March, June and September. A planning meeting of Executive Committee members in December 2009 established the calendar of meetings and determined the distribution of the different agenda items in 2010. This is provided in Annex I.

3. A detailed account of the work undertaken at each of the meetings of the Standing Committee in 2010 is contained in the following reports: *Report of the forty-seventh meeting of the Standing Committee* (A/AC.96/1084); *Report of the forty-eighth meeting of the Standing Committee* (A/AC.96/1092); and *Report of the forty-ninth meeting of the Standing Committee* (A/AC.96/1093). A list of documents relating to these meetings is provided in Annex II.

### II. Issues covered by the Standing Committee in 2010

#### A. Programme budgets and funding

4 At each of its meetings, the Standing Committee considered updates on overall programme budgets and funding through which it was kept informed of programme requirements, budgetary measures and funding levels. The Committee also adopted decisions, as listed in section III below. At the June meeting, the Committee also considered the Global Report on UNHCR's activities in 2009. In its September meeting, the Standing Committee reviewed the Revised Biennial Programme Budget for 2010 and 2011, and discussed the Report of the Advisory Committee on Administrative and Budgetary Questions (ACABQ) on the budget for 2010-2011.

#### **B.** International Protection

5. In March, the Committee heard a presentation on birth registration, a topic considered for an Executive Committee conclusion on international protection. The June meeting included a debate on the Note on International Protection, as well as progress reports on resettlement; protection capacity and delivery; and on the Agenda for Protection: review and way forward.

#### C. Regional activities and global programmes

6. Regional reviews of UNHCR's programmes and activities in all five regions: Africa; the Americas; Asia and the Pacific; the Middle East and North Africa; and Europe, were considered comprehensively at the Standing Committee's meeting in March. In addition to the regional reviews, the Committee discussed the Office's global programmes and

partnerships. The Committee also received a report on UNHCR's emergency preparedness and response, and an update on the global needs assessment/prioritization. In June, the Committee received an update on staff safety and security issues, including refugee security.

#### **D.** Programme/Protection policy

7. In March, the Standing Committee received an oral update on the third meeting of the High Commissioner's Dialogue on Protection Challenges, which took place in December 2009. In June it received updates on children of concern, and age, gender and diversity mainstreaming; and it considered UNHCR's programme in the United Nations: proposed strategic framework for the Biennium 2012-2013.

#### E. Coordination

8. The Committee considered elements for UNHCR's oral update to the 2010 substantive session of the Economic and Social Council at its June meeting. An update on coordination issues and strategic partnerships was discussed in the September meeting.

# F. Management, financial control, administrative oversight and human resources

9. At each meeting, the Standing Committee received an update on UNHCR's structural and management change process. In March, the Committee received a report on follow-up measures taken in response to the recommendations in the Report of the Board of Auditors for 2008. It also received oral updates on the work of the Inspector General's Office, and on progress made in achieving gender equity in UNHCR staffing. In June, the Committee was apprised of progress made on the introduction of International Public Sector Accounting Standards (IPSAS) and of strategies envisaged for funding end-of-service and post-retirement benefits.

10. In September, the meeting considered the Report of the Board of Auditors on UNHCR's accounts for 2009, discussed measures taken or proposed in response to recommendations in the Report of the Board of Auditors for 2009 and previous years and received a summary report on main risk areas raised in the Report of the Board of Auditors. The Office of Internal Oversight Services presented its annual report on internal audit activities undertaken at UNHCR for the period 1 July 2009 to 30 June 2010. It also received an update on human resources issues.

#### G. Governance

11. In March, the Standing Committee adopted the work programme for 2010 as proposed at its December 2009 planning meeting. In June, under governance issues, the Committee called on delegations to provide suggestions for issues to be included in the High Commissioner's opening statement at the sixty-first session of the Executive Committee.

#### H. Consultations

12. In accordance with its standard practice, the Standing Committee held informal consultative meetings and briefings in the course of the year on issues requiring in-depth discussion or necessary action. In 2009, the Standing Committee held an informal consultative meeting in November to discuss the proposed revision to the financial rules; and in December it received a briefing on refugee protection and solutions in urban areas and other international protection developments. In 2010, the Standing Committee held an informal consultative meeting in January to discuss proposals for a conclusion on international protection in 2010, and in February it received two briefings: one on the Policy Development and Evaluation Service's workplan for 2010 and another on the Inspector General's Office. In August, the Standing Committee was briefed on assistance provided to flood affected Afghan refugees in Pakistan following the devastating floods. Finally, in September, there was an informal consultative meeting held to discuss the Revised 2011 Budget.

### III. Standing Committee decisions

13. In accordance with the authority vested in it by the Executive Committee, the Standing Committee adopted a number of decisions which are annexed to the reports of the different Standing Committee meetings, as follows:
