

#### **II.** Annotations

#### 1. Opening of the session

The Chairperson of the Executive Committee will open the sixty-fourth session on Monday, 30 September 2013, at 10 a.m., in conference room XIX of the Palais des Nations in Geneva.

#### 2. Adoption of the agenda and other organizational matters

The Executive Committee will consider the provisional agenda, contained in document A/AC.96/LXIV/1, as the basis for adoption of the agenda of the session.

# **3.** High-level segment on solidarity and burden-sharing with countries hosting Syrian refugees

In view of the extraordinary circumstances of the Syrian refugee crisis, its impact on host countries, and the scale of humanitarian needs, the Committee will hold a high-level segment, at the ministerial level, to consider how best to mobilize a range of measures for enhanced international solidarity and burden-sharing.

#### 4. Statement by the High Commissioner and general debate

The High Commissioner's statement will provide an overview of the operational and policy priorities facing his Office. The Committee will have received in good time an outline of the High Commissioner's statement.

The general debate is articulated around issues raised in the statement of the High Commissioner. The Committee will also have before it brief updates on recent operational developments at the regional and global levels.

The formal list of speakers for the general debate will be opened on 2 September 2013.

#### 5. Consideration of reports on the work of the Standing Committee

Under this item, the Committee will review the results of the work of the Standing Committee on international protection and on programme budgets, management, financial control and administrative oversight.

#### (a) International protection

Of particular relevance to the deliberations of the Committee under this sub-item are:

- (i) The High Commissioner's Note on international protection (A/AC.96/1122);
- (ii) Note on statelessness (A/AC.96/1123);
- (iii) Report on the work of the Standing Committee (A/AC.96/1131); and
- (iv) *Reports of the fifty-sixth and fifty-seventh meetings of the Standing Committee* (A/AC.96/1121 and A/AC.96/1129).

In view of the substantial agenda and time constraints, delegations are strongly encouraged to integrate the statements they would normally make under this agenda item with their statements under agenda item 4, or, alternatively, to limit their interventions to 3 minutes.
