#### 1. VENUE

- The UNHCR Africa NGO and Multi-stakeholder Consultation will take place from 10-11 September 2019 at the Nelson Mandela Foundation (107 Central St, Houghton Estate, Johannesburg, 2198 Johannesburg, South Africa)

#### 2. CRITERIA FOR PARTICIPATION

NGO, refugees, civil society and private sector who wish to attend the consultations should meet at least one of the below listed criteria:

- Implementing partner of UNHCR in 2018/2019.
- Operational partner of UNHCR with a <u>demonstrated interest</u> in the solution to the problem of refugees, internally displaced persons and/or statelessness and/or in the theme of the Consultations. A mandatory recommendation letter





by the relevant UNHCR field office supporting the NGO's participation should be provided.

- Member of ICVA (International Council of Voluntary Agencies www.icvanetwork.org)
- Consultative status with ECOSOC (Economic and Social Council) with a
  demonstrated interest\_in the solution to the problem of refugees and other
  persons of concern to UNHCR and/or in the theme of the Consultations. For

- Given the regional nature of the Consultations, we will give priority for participation of NGO colleagues from the Southern Africa. This consultation will encourage lively discussions amongst UNHCR's new southern Africa region: Angola, Botswana, Comoros, Kingdom of eSwatini, Lesotho, Madagascar, Malawi, Mauritius, Mozambique, Namibia, Seychelles, South Africa, Zambia and Zimbabwe, Democratic Republic of Congo (DRC) and the Republic of Congo. Moreover, in line with the theme of the consultations, we strongly encourage NGOs with interest and expertise in the Global Compact of Refugees to register.

- All participants are welcomed to the Consultations on the first day, 10 September. The second half day, 11 September will be Consultations with I/NGOs and refugees, only.

## 4. REGISTRATION (05 August to 22 August 2019)

- The number of delegates attending the Consultations should be two participants per organization and two participants per NGO consortium.
- Registration must be done using the INDICO system put in place by the United Nations Office at Geneva. - Failure to complete the INDICO registration form correctly will delay your security badge collection at the Nelson Mandela Foundation venue.





- Upon completion of the INDICO registration form and approval of participation by UNHCR, participants will be provided with a QR code.
- The QR code (printed copy or on mobile) should be provided to the UNHCR at the registration table at the Nelson Mandela Foundation venue.
