# Mr. Valentin Tapsoba, Director, UNHCR Regional Bureau for Southern Africa

Nearly 71 million people are now forcibly displaced around the world. More than a third of the world's forcibly displaced people are in Africa, including 6.3 million refugees. Close to 70 percent of African migration is intra-African. While we are witnessing growing closure and intolerance in some parts of the world, there is also an outstanding fact: African hospitality towards refugees is heartfelt, tangible and longstanding. African countries came together 50 years ago to enshrine these principles in the Organization of the African Union Convention, a truly enlightened document that continues to represent one of the most progressive approaches to refugee protection in the world. Despite the continent's own social, economic, climatic and security challenges, Africa's governments and people have kept borders, doors and hearts open to millions in need, with Uganda, Sudan and Ethiopia among the top ten refugee-hosting countries, globally.

Today, multilateralism is under stress. Trust amongst the UN Member States is low, and agreement on the pressing issues of the day is elusive. However, the United Nations and the accompanying multilateral system depend on more than heads of state and governments. The UN Charter begins, resoundingly, with a declaration by 'we the peoples'. In a time of global fragmentation, but also one of incredible connectedness and globalization, the actions and voices of people, are needed more than ever.

The Global Compact on Refugees, adopted by the UN Member States in 2018, marked a milestone and opportunity to reinvigorate multilateral cooperation and is bringing in a transformation to the way we have been dealing with forced displacement situations. The Compact intends to broaden the base of support for refugees and make it more predictable, to accelerate the shift away from outdated camp-based response models; to drive refugee inclusion in local communities; to mobilize development resources, civil society and the private sector; and to refocus attention on solutions.

Partnerships are, without any doubt in UNHCR's DNA, and NGOs are our lifeblood. Together, we combine to drive the largest and most dependable response to refugee crises around the world. But, if we are to truly succeed in bringing in innovative and sustainable solutions to refugee situations through a new way of working, we need a "whole-of-international-community" multi-stakeholder involvement of NGOs, civil society, donors, governments, the private sector and refugees, themselves.

This is UNHCR's first-ever regional NGO and Multi-stakeholder Consultations in Africa, and it is taking place under the auspices of the newly established Regional Bureau for Southern Africa. Starting this year, UNHCR is moving closer to the point of delivery, through decentralization and regionalization that places resources, early warning mechanisms and decision-making power closer to the field.

This Consultation will seek to encourage lively and targeted discussions amongst participants that represent 16 countries: Angola, Botswana, Comoros, the Kingdom of eSwatini, Lesotho, Madagascar, Malawi, Mauritius, Mozambique, Namibia, Seychelles, South Africa, Zambia and Zimbabwe, Democratic Republic of Congo (DRC) and the Republic of Congo. The Consultations seek to bring together NGOs, advocates, businesses, professors, artists, media and refugees in a true coalition. One of the key outcomes of the Consultations is to explore how multi-partnerships at the regional and national levels can contribute to the implementation of the Global Compact on Refugees. This momentum should also be capitalized to establish a regional platform to end statelessness through regional bodies. Together these partnerships have the potential to be the building blocks for a vibrant, self-assertive region with peace, security and socio-economic development to put an end to displacement.

Nelson Mandela, Madiba, continues to inspire people committed to justice and righteousness the world over. It is fitting, and humbling, to co-organize this event with the Nelson Mandela Foundation.

They say all journeys start with the first step – let us take that first step today.





## A South African National Treasure

Esther Mahlangu is one of South Africa's most globally acclaimed artists. She was born in 1935 and has spent her life touring the world, dressed in her beautiful traditional Ndebele clothing, touching all who she meets.

Mam Esther has collaborated with numerous respected museums, artists, curators, brands, celebrities and entities over the course of her illustrious career.

In 1991, she became the first lady and first African to be invited to create a 'BMW Art Car' thereby joining other respected artists such as David Hockney, Andy Warhol, Roy Lichtenstein and Frank Stella.

In 2016, she collaborated with Belvedere Vodka and John Legend, to create the labels for a limited range of Belvedere Vodka bottles to raise money to be used for the fight against HIV in Africa.

In the same year, she collaborated once again with BMW to paint panels in their new 7 Series for launch at the Frieze Art Fair in London and participated in the 'SA – Art of a Nation' exhibition at the British Museum.

In 2017, she joined Dr Makaziwe Mandela, the eldest daughter of Mr Nelson Mandela, to unveil a series of artworks that she created in 2004 in collaboration with Mr Mandela for the first time at The Melrose Gallery in Johannesburg.
