<u>Title of session</u>: Protecting rights in mixed movements: practical and principled responses in the post-compacts era

Date: Thursday, 4 July 2019

Executive Summary:

The Global Compact on Refugees (GCR) and the Global Compact for Safe, Orderly and Regular Migration (GCM) provide important new frameworks for responding, amongst other things, to rights violations experienced by people on the move, including in mixed movements. Both include strong calls for a whole-of-society approach to these issues. Civil society therefore has an important role to play in promoting more effective responses to mixed movements, which can ensure greater respect in practice for the rights of refugees and others on the move. The session will explore ways in which such responses can be strengthened in the areas of:

- alternatives to detention,
- regular and complementary pathways and
- safe and dignified returns and reintegration of refugees and migrants.

The session will consider ways in which the Global Compact on Refugees (GCR) and the Global Compact for Safe, Orderly and Regular Migration (GCM) offer elements that may be relevant to building protection and solutions strategies that address the needs of refugees and migrants respectively, in 'mixed' situations, in countries of transit or destination.

Concept Note:

• Background and link to the theme

The New York Declaration for Refugees and Migrants recognises that some people move in search of new economic opportunities and horizons, that others move to escape armed conflict, persecution or human rights violations, among others, and that many move for a combination of reasons. It includes commitments that apply to both refugees and migrants, notably in relation to strengthening respect in practice for the human rights of all people on the move. On its basis, two separate instruments have subsequently been adopted in 2018, the Global Compact on Refugees (GCR) and the Global Compact for Safe, Orderly and Regular Migration (GCM). Both contain elements that may be relevant to building protection and

solutions strategies that address the needs of refugees and migrants respectively who are arriving or present, in 'mixed' situations, in a country of transit or destination.

The session will explore concrete ways the two compacts can be applied to mixed movement situations and particularly in respect of **alternative to detention**, **regular and complementary pathways and safe and dignified returns and reintegration** of refugees and migrants. It will provide information on specific situations and highlight good practices.

The table below includes the provisions of the two compacts that can be applied to mixed movement situations that will be illustrated during the event:
