MAIN ACTIVITIES

Protection

- Ensuring protection for all persons of concern to UNHCR, including refugees, asylum-seekers and stateless persons within the sub-region, and resettled refugees in Australia and New Zealand.
- Affirming and developing the international refugee protection regime in the sub-region and promoting law, policy and practices that increase access to quality asylum procedures and durable solutions.
- Monitoring the implementation of the 1951 Refugee Convention and the 1967 Protocol.
- Monitoring and reporting the situation of refugees and asylum-seekers in 'offshore processing' sites and detention facilities.
- Increasing capacity in refugee status determination in Papua New Guinea and Pacific Island countries by providing practical support to introduce protection safeguards in immigration procedures.
- Providing technical assistance in Pacific Island countries to support the development of national refugee legislation and accession to the refugee and statelessness conventions through capacity building and training activities including the Pacific Protection Learning Programme.

Advocacy

- Engaging with States and civil society in advocating for long-term cooperation on the protection of refugees and asylum-seekers in the region, including a reduction in the number of refugees and asylum-seekers in detention, the duration of detention, and the attainment of durable solutions for those found to be in need of protection.
- Providing legal and policy submissions to ensure the protection of refugees and asylum-seekers in the region.
- Raising public awareness and promoting support for refugees and asylum-seekers in the region through sensitization campaigns, including 'Human Lives, Human Rights' in Australia.

Durable solutions

Working closely with Australia and New Zealand to help determine the composition of their resettlement intakes and to encourage the development of resettlement policy and practice in line with international humanitarian principles.

External relations

- Promoting civil society coordination and best practice through consultations with non-government organizations in Australia and New Zealand.
- Promoting the positive involvement of key stakeholders in refugee issues and continued government contributions through public events, as well as briefings with parliamentary and governmental interlocutors.
- Providing information to refugees and asylum-seekers on available services and support.
