Quotations should be submitted via **Annex B**, duly signed and stamped Financial Form.

- Currency: USD
- Unit Cost: DAP Lviv or EXW supplier's location
- Cost of all items/goods;
- Total cost of goods (all inclusive);
- Certificates of goods;
- Delivery Lead Time in calendar days;
- Country of origin of goods;
- Stock shelf life in days.
