3. No document downloading links are accepted. All documents must be attached to the emails.
4. If the supplier is uploading a number of small files, please zip the files into a ZIP folder and upload the folder instead of each file individually.
5. All files must be free of viruses and not corrupted in case of online submission through email.
6. UNHCR reserves the right to accept or reject any offers that are not following the email submission instructions
7. UNHCR may also request **SAMPLES** from the potential suppliers which can be returned if the offer of the supplier is found not to be reasonable.
8. UNHCR may also split the award based on **the lowest cost and required quality** per winter kit items and award contracts to one or more suppliers.

You are kindly asked to hold your quotation valid for at least **60** days.

UNHCR is not obliged to award a contract for the requested goods/services and may increase or decrease the quantities based on the actual needs and availability of the budget.






The standard payment terms of UNHCR are net **30** days upon satisfactory delivery of goods and acceptance thereof by UNHCR.

Please find attached in ANNEX C, the UNHCR's General Conditions of Contracts for the purchase of goods of July 2018 and Annex D, the UNHCR's vendor registration document that can be filled and submitted with the offer. You must clearly indicate in your quotation if you accept them.
