ADDITIONAL INFORMATION FOR COMPLETION:

- 1. The form should be typewritten in uppercase and completed clearly and accurately ensuring that all questions are answered.
- 2. Year Established: 3 years of operation is a minimum.
- 3. Name under which the bank account is held should be the company name. Following UNHCR payment policies, any decisions to permit third party payment are at the sole discretion of UNHCR and are subject to detailed scrutiny and special approval. Any proposed different names on the bank account should be clearly explained and fully justified. A copy of a Bank Statement matching Vendor Name and Address should be provided.
- 4. DFI ID is transit number for US and Canada and Swift code for Europe and the rest of the world.
- 5. Please read carefully the enclosed UNHCR General Term and Conditions, as signing of the form signifies acceptance. The form should be stamped and signed by the person completing it and their name and title should be typed, along with the date, otherwise, official electronic signature may be acceptable.
