The following cases of damaged product shall be considered as "user / customer carelessness" and shall not be covered under warranty

Exterior damages to the plastic bodywork:

- 1. Scratches, cracks, deformation
- 2. Dirt, stains, adhesive remains, halos

Possible causes:

- Shocks / impacts suffered
 Product dropped (even from little heights)
 Exposure to heat, cold or weathering
- Writings with marker or similar tools
 Application of adhesive labels / tapes or similar
 Use of abrasive / aggressive / chemical agents for cleaning

How to avoid:

- 1. Handle the device carefully and prevent it from being hit and dropped Avoid exposure to heat, cold, weathering.
- 2. Clean carefully with a soft cloth to remove dust, **DO NOT** use abrasive / aggressive / chemical tools or agents for cleaning.

Avoid writing or sticking labels or anything else on the device bodywork.

Damages to USB Cable / Connector / Jack:

- 1. Connector's breaking
- 2. Cable insulant's stripping
- 3. Oxide / rust formation

Possible causes:

- Excessive and/or repeated cable bending. Repeated connector insertion / disinsertion. Shocks / impacts suffered.
- 2. Pinching / contact / rubbing with sharp parts or edges.
- 3. Exposure to humidity / corrosive atmosphere or to chemical agents.

How to avoid:

- Avoid excessive bending, leave an adequate amount of space behind the device Avoid repeated connector insertion / disinsertion.
 Prevent it from being hit.
- 2. Avoid to pinch cable between objects, avoid contact and/or rubbing with sharp parts or edges.
- 3. Avoid the exposure to humidity / corrosive atmosphere or to chemical agents, use the device in a place that meets the appropriate environmental conditions (indoor use).

Damages to the acquisition surface

1. Scratches, chipping, halos

Possible causes:

- 1. Presence of jewels or similar (e.g.: rings, bracelets, etc.) during the fingerprint acquisition process, presence of abrasive particles (e.g.: sand grains) on the surface or on the fingers / hand.
- 2. Accidental or intentional contact with sharp / pointed objects
- 3. Use of abrasive tools and/or aggressive chemical substances for surface cleaning.

How to avoid:

1. Always remove any object from hand and from fingers that could damage the surface, if possible, wash or clean the hands*

Blow on the surface to remove as much dirt as possible, both before acquisition process and before cleaning.

*Note: for better fingerprint image quality we suggest to clean hands using wet wipes with lanolin (e.g.: baby wipes), especially in case of dry skin and/or with ruined or poor quality fingerprints

- 2. Avoid contact with sharp / pointed objects
- 3. DO NOT use abrasive tools or aggressive chemical components to clean the surface, use specific cleaning kit instead (e.g.: camera lens cleaning kit).

Entry of dust, dirt, liquids inside the optical module

Possible causes:

Dirt / dust: particles pushed inside during cleaning process, use of cloths or wipes that release lint and particles.

Liquids: direct spraying or pouring on the surface, submerging.

How to avoid:

During cleaning process, avoid spraying or pouring liquids directly on the surface, avoid pushing the dirt towards the edges with the cleaning cloth / wipes.

Use soft cloths or wipes that do not release lint or particles.

Damages caused during transport / shipping

Possible causes:

Poor or inadequate packaging

Absence, insufficiency or inadequacy of protective material inside packaging.

How to avoid:

Ship the device in its original packaging (if present and in good conditions) or in a suitable one with plenty of protection material

(e.g.: pluriball/bubblewrap film, air cushion, polyethylene shaped parts)

DO NOT use polystyrene/styrofoam or paper, because they release little particles that could enter into the device optical module.

As additional protection, it is recommended to:

- Put the device inside a clean plastic bag.
- Wrap the carton box with cellophane film or similar.
