

UPDATE ON PROGRAMME BUDGETS AND FUNDING IN 2005  
AND PROJECTIONS FOR 2006

I. INTRODUCTION

1. At the 32<sup>nd</sup> meeting of the Standing Committee in March 2005, UNHCR presented the financial projections for the current year.<sup>1</sup> The present document provides further updated information on programme expenditure and funding in 2005 as well as final expenditures figures for 2004 (Annex 1), a list of transfers from the 2005 Operational Reserve Categories I and II (Annexes II and III), information on refugee populations and changes according to available statistics covering the period 1 January to 31 December 2004 (Annex IV), a list of overall contributions in 2005 (Annex V), and a breakdown of these contributions by NGOs, foundations and private donors (Annex VI). A draft decision on overall programme budgets and funding for 2005 is proposed in Annex VII. Furthermore, information on initial projections for 2006 is also provided at the end of this document.

II. INCOME AND EXPENDITURE IN 2004

2. Total income for 2004 amounted to \$1,001.2 million. This amount comprises contributions and miscellaneous income of \$805.2 million under the Annual Programme Budget, \$158.3 million under the Supplementary Programme Budgets, \$27.7 million under the United Nations Regular Budget and \$10.0 million for Junior Professional Officers (JPOs).

3. Total expenditure in 2004 amounted to \$1,062.6 million, while the carry-over was \$73.3 million (Annex I, columns 1 and 5). The Annual Budget accounted for \$905.8 million in expenditure, including \$27.7 million under the United Nations Regular Budget and \$8.4 million for JPOs. Total expenditure under the Supplementary Budgets was \$156.8 million. In comparison to 2003, expenditure in 2004 under the Annual Budget was up by \$155.4 million, reflecting a higher level of available funds.

4. The 2004 Annual Programme Budget closing balance was \$24.3 million, which was \$24.2 million less than in 2003. The closing balance for Supplementary Programme Budgets was \$40.4 million.

### III. UPDATE ON PROGRAMME BUDGETS AND FUNDING FOR 2005

5. Total budgets for the current year currently amount to \$1,358.7 million (Annex I, column 3), comprising \$945.8 million under the Annual Programme Budget, \$375.6 million under seven Supplementary Programme Budgets, \$28.8 million under the United Nations Regular Budget and \$8.5 million for JPOs (the latter figure accounting for the \$1.5 million increase under the Annual Budget as compared to that approved by the Executive Committee).

#### A. Annual Budget

6. Total budgetary requirements approved by the Executive Committee<sup>2</sup> for 2005 amounted to \$981.6 million, comprising \$945.8 million for the Annual Programme Budget (including \$62.5 million and \$50 million respectively for Operational Reserve Categories I and II), \$28.8 million for the United Nations Regular Budget and \$7 million for JPOs (Annex I, column 2). As noted above, the budget for JPOs has been increased by \$1.5 million, thereby bringing the current Annual Budget to \$983.1 million.

7. As a precaution against potential funding shortfalls, the High Commissioner, in early 2005, imposed caps on the programme and support budgets. Thus, programme and non-staff administrative costs budgets were capped at 95 per cent. These measures required reprioritization at both the field and headquarters levels to identify activities for potential non-implementation amounting to \$26 million. Current exchange rate projections, with a slight strengthening of the US dollar since the beginning of the year, will require a very careful management of expenditures in relation to income received, thereby reducing the High Commissioner's flexibility in addressing new developments and in the management of UNHCR's field operations.

8. With a carry-over from 2004 of \$24.3 million and \$588.2 million so far received in contributions, the total amount of funds available under the Annual Programme Budget as at 31 May 2005 stood at \$612.5 million. For the Annual Programme Budget to be fully funded, UNHCR therefore needs to receive further income of \$333.3 million during the remainder of 2005. However, projections for further income currently amount to \$197.2 million (excluding further contributions to Operational Reserve Category II, miscellaneous income and the seven per cent Supplementary Budget Support costs), leaving a projected budgetary shortfall of \$136.1 million (Annex I, columns 5 to 10).

9. Transfers from the 2005 Operational Reserves are shown in Annexes II and III. Transfers from Category I total \$11.8 million and include some \$7.6 million for Africa. Transfers from Category II total \$27.5 million. Thus, as at 31 May 2005, the balance under Category I stood at \$50.7 million and under Category II at \$22.5 million.

10. The United Nations Regular Budget contribution for 2005 has been increased by \$9.7 million to \$38.5 million. The increase is comprised of \$5.8 million for security enhancements at UNHCR Headquarters in Geneva and \$3.9 million for exchange rate-related

cost increases and an incremental increase in the contribution. As the security enhancements were not budgeted for, the original Regular Budget allocation of \$28.8 million will be increased by \$5.8 million to \$34.6 million, thereby bringing the current 2005 Annual Budget to a level of \$988.9 million (including the \$1.5 million increase for JPOs as noted in paragraphs 5 and 6 above). The remaining \$3.9 million increase under the Regular Budget will be treated as earmarked income against budgeted requirements.

**B. Supplementary Programme Budgets**

11. Total requirements for Supplementary Programme Budgets in 2005 stand at \$375.6 million as at 31 May 2005 (Annex I, column 3). With a carry-over from 2004 of \$40.4 million and \$177.2 million in contributions, \$217.6 million were available under the 2005 Supplementary Budget Programmes. Projected further income amounts to \$64.6 million, leaving a projected budgetary shortfall of \$93.4 million. Estimated expenditure stands at \$75.5 million as at 31 May 2005.

**IV. INITIAL PROJECTIONS FOR 2006**

12. Programme submissions from field offices and headquarters units for 2006 amounted to \$1,158.7 million (excluding \$70 million pertaining to the mainstreaming of the Chad Supplementary Budget). As a result of an extensive review process, which is still ongoing, these submissions were reduced to \$1,144.3 million (now including some \$70 million for Chad). This provisional amount corresponds to an increase of some 16.6 per cent over the 2004 Annual Programme Budget, mainly reflecting the mainstreaming of the Burundi and Chad operations and projected cost increases due to exchange rate variations. Further updates will be provided to the Standing Committee at its next session.

## DRAFT DECISION ON OVERALL PROGRAMME BUDGETS AND FUNDING FOR 2005

*The Standing Committee,*

*Recalling* the Executive Committee's decision at its fifty-fifth session on administrative, financial and programme matters (A/AC.96/1003, para. 24) as well as its discussions under the programmes, budgets and funding item at the thirty-second meeting of the Standing Committee,

*Reaffirming* the importance of international burden and responsibility sharing in reducing the burden on countries hosting refugees, especially developing ones,

1. *Notes* that the amount of \$981.6 million, approved by the Executive Committee at its fifty-fifth session for UNHCR's Annual Budget for 2005 (which included \$28.8 million from the United Nations Regular Budget and \$7 million for Junior Professional Officers), is to be increased by \$7.3 million to \$988.9 million in order to absorb an additional Regular Budget allocation related to unbudgeted security enhancements at UNHCR's Headquarters (\$5.8 million) and an increase in the Junior Professional Officers' budget (\$1.5 million);
2. *Notes* with continuing concern that projected income for the year 2005 reveals a possible shortfall of \$136.1 million under the Annual Programme Budget (excluding further contributions to Operational Reserve Category II, miscellaneous income and the seven per cent Supplementary Budget Support costs), and that the High Commissioner will be compelled to further reduce activities under the Annual Programme Budget in reaction to anticipated funding shortfalls;
3. *Notes* that the 2005 Supplementary Programme Budgets currently amount to \$375.6 million;
4. *Recognizes* that emergencies and unforeseen activities unfolding in 2005 may result in the need for additional or expanded Supplementary Programmes and that additional resources, over and above those for existing budgets, would be needed to meet such needs; and
5. *Urges* member States, in the light of the extensive needs to be addressed by the Office of the High Commissioner, to continue to respond generously and in a spirit of solidarity, and in a timely manner, to his appeal for resources to meet in full the approved 2005 Annual Programme Budget, as well as the requirements of the 2005 Supplementary Programme Budgets.
