II. Annotations

Item 1 Opening of the session

The Chairperson of the Executive Committee will open the sixty-fifth session on Monday, 29 September 2014, at 10 a.m., in the Assembly Hall of the Palais des Nations in Geneva.

Item 2 Adoption of the agenda and other organizational matters

The Executive Committee will consider the provisional agenda contained in document A/AC.96/LXV/1 as the basis for adoption of the agenda of the session.

Item 3 High-level segment on enhancing international cooperation, solidarity, local capacities and humanitarian action for refugees in Africa

The objective of the high-level segment is to galvanize the international community's support to address the complex displacement crises on the African continent – both emergencies and protracted situations – that have forced an unprecedented number of people to flee their homes in search of safety. In view of the profound humanitarian needs and insufficient progress on solutions, and in the interest of regional peace and stability, the Committee will consider measures for enhanced international solidarity and burden-sharing.

The list of speakers for the high-level segment will be opened on 1 September 2014.

Item 4 Statement by the High Commissioner and general debate

The High Commissioner's statement will provide an overview of the operational and policy priorities facing his Office. The Committee will have received in good time an outline of the High Commissioner's statement.

The general debate is articulated around issues raised in the statement of the High Commissioner. The Committee will also have before it brief updates on recent operational developments at the regional and global levels.

The list of speakers for the general debate will be opened on 1 September 2014.

Item 5 Consideration of reports on the work of the Standing Committee

Under this item, the Committee will review the results of the work of the Standing Committee on international protection and on programme budgets, management,

financial control and administrative oversight.
