BACKGROUND PAPER

<u>Operational Focus: Implementing partnership – A Framework for establishing and maintaining UNHCR partnerships</u>

Wednesday 4 July 2012, 14h30 – 18h30 – Room 3

Since UNHCR was established more than 60 years ago, it has been working in close partnership with NGOs to protect and assist refugees. One major manifestation of these partnerships is through programs facilitated by UNHCR and implemented by NGO partners. In 2010, UNHCR channeled nearly 30% of its \$1.9 billion budget through 685 NGOs, including 533 national NGOs. UNHCR is reviewing the whole framework of cooperation with implementing partners, including the types and formats of agreement between UNHCR and NGOs, the terminology used, the mechanisms for joint management of agreements, joint monitoring of projects and mutual establishment and review of partnership. UNHCR is committed to improve the current procedures with the aim to assist in the establishment and maintenance of implementing partnerships with NGO partners.

This dialogue on how implementing partnerships are established and maintained is not merely technical. Partnership dynamics among UNHCR and NGOs have always been influenced by the manner in which UNHCR and NGO field offices engage with one another in implementing projects. A new framework for engagement could present significant new opportunities as well as challenges for UNHCR and its NGO partners in serving refugees together.

This session will brief and, through breakout sessions, solicit feedback from NGOs on UNHCR's ongoing efforts to strengthen its partnerships with NGOs through consultations with stakeholders and establishment of a support service, Implementing Partnership Management Service (IPMS) and, in particular, working through a Field Reference Group of Implementing Partners and UNHCR colleagues to draft Standard Operating Procedures to establishing and maintain implementing partnerships with NGO partners.

The draft Standard Operating Procedures for establishing and maintaining partnerships, along with the draft Implementing Partnership Agreement, will be shared in advance with NGO Consultation participants, who are strongly encouraged to read the materials prior to the session.
