4. **Financial Offer:** Please submit your price offer in PKR, using financial form (**Annex C**). Please note that supplier submit bid with required needs of Supply of Fire Systems (**Annex – B**).
UNHCR will award the Contract (s to a successful bidder (s) for Supply of Fire Systems and Maintenance Services lots.

UNHCR is GST exempted, with this regard, price must be given without GST & Withholding tax.

UNHCR reserves the right to award either a full or partial contract (s) for the supply and delivery of Maintenance Services of the required items to one or more suppliers. The basis of award of contract will be the lowest most technically compliant supplier (s)

Financial offer that meets UNHCR needs in the best manner. UNHCR's technical evaluation process may include visiting your company premises to inspect the products quality, storage of the products, maintenance service capacity, your company's delivery capacity and products compliancy to Technical Specifications detailed in Annex B as part of the evaluation process.

Your quotation must be valid for at least 30 calendar days. The standard payment terms of UNHCR are net 30 days upon satisfactory delivery of goods or services and acceptance thereof by UNHCR.

Please find attached (**ANNEX D**) the UNHCR's General Conditions of Contracts for the Provision of Goods and Services. You must clearly indicate in your quotation if you accept them.
