The Office of the United Nations High Commissioner for Refugees (UNHCR), Sub-Office Peshawar requests qualified suppliers in Pakistan to submit a price quotation for the Fumigation services for UNHCR Sub Office Peshawar KPK, tender to UNHCR Sub Office Peshawar in Pakistan.

UNHCR's minimum delivery period is as per require schedule, UNHCR issues a Purchase order and subsequent requests for the Provision disinfecting / fumigation services for UNHCR Sub Office Peshawar.
2. **Incoterms:** Delivered at UNHCR SUB- Office Peshawar
3. **Financial Offer:** Please submit your price offer in PKR, using financial form (**Annex B**).

UNHCR is exempt from all direct taxes and customs duties. Since UNHCR is undertaking local procurement, therefore, price has to be given without VAT/GST. If requested by the successful bidder, UNHCR shall obtain from authorities GST exemption, upon provision of all required documents by bidder.

Your quotation must be valid for at least 30 calendar days. The standard payment terms of UNHCR are net 30 days upon satisfactory delivery of services and acceptance thereof by UNHCR.

Please find attached (**ANNEX D**) the UNHCR's General Conditions of Contracts for the Provision of Goods (July 2018). You must clearly indicate in your quotation if you accept them.
