The Office of the United Nations High Commissioner for Refugees (UNHCR), Sub-Office Peshawar requests qualified suppliers in Pakistan to submit a price quotation for the supply of steel containers for storage of goods at UNHCR Warehouse Azakhail Nowshera KPK, Pakistan.

- 3. Financial Offer: Please submit your price offer in PKR, using financial form (Annex C).

UNHCR is exempt from all direct taxes and customs duties. Since UNHCR is undertaking local procurement, therefore, price must be given without VAT/GST. If requested by the successful bidder, UNHCR shall obtain from authorities GST exemption, upon provision of all required documents by bidder.

The standard payment terms of UNHCR are net 30 days upon satisfactory delivery of services and acceptance thereof by UNHCR.

Please find attached (ANNEX D) the UNHCR's General Conditions of Contracts for the Provision of Goods (July 2018). You must clearly indicate in your quotation if you accept them.
