Operational Context

India continues to be a generous host to refugees and asylum-seekers from across the region and beyond. UNHCR works in close coordination with the Government of India, NITI Aayog and other UN agencies in fulfilling its mandate of ensuring access to protection, solutions, and humanitarian assistance to persons forced to flee.

Civil society organizations, working in partnership with UNHCR, are at the forefront of the refugee response ensuring that assistance reaches the most vulnerable within the overall objective of “leaving no one behind”. Partnership agreements are in place with eight national NGOs.


To ensure that refugees are included in the UN's work on Sustainable Development Goals, UNHCR maintains close engagement with the UN Country Teams in India and the Maldives. In 2024, resilience building, and self-reliance remain top priorities in furthering UNHCR's efforts to support refugees and asylum seekers.





Refugee Resilience Shines at Agricultural Summit

Sri Lankan refugees joined an Agricultural Summit organized by the South India Chamber of Commerce and Industry (SICCI) in Chennai, Tamil Nadu, showcasing their agricultural skills and products such as vermicompost, oils, and plant-based cosmetics. Additionally, two self-help groups of refugee women delighted attendees with traditional Sri Lankan delicacies, adding a taste of their homeland to the event.

This summit not only provided an empowering platform for economic advancement for refugee women but also underscored the ongoing partnership between SICCI and UNHCR in advocating for refugee inclusion and self-sufficiency, reflecting a shared commitment to fostering dignity and opportunity for displaced populations.

The refugee self-help groups are supported by the Commissionerate of Rehabilitation and Welfare of Non-Resident Tamils, Tamil Nadu.
