


2024 Budget

The 2024 final budget reached \$10.8 billion





The final supplementary budget for Sudan situation reached \$163.7 million





2024 provisional expenditure compared to 2023









- Expenditure (provisional) in 2024 of \$5.0 billion has remained at a similar level to 2023 (\$5.2 billion).
- Funds available (provisional) in 2024 of \$5.2 billion was 9% lower than that of 2023 (\$5.7 billion).
- Despite a funding gap (51.6% in 2024 compared to 47.7% in 2023), implementation rate compared to funds available has exceeded that of 2023.



Preliminary global achievements and results



Over **2.3 million people provided** with shelter and housing assistance in **63 operations**.



Around **15 million people** received health care services in **60 operations**.



Around 6 million people provided with multipurpose cash assistance.



Nearly 17 million displaced people received protection services in 108 operations.




4.5 million people assisted in obtaining civil status, identity and legal status documentation in 83 operations.



203,700 resettlement cases were submitted, with 116,500 refugees departing for resettlement.



Regional expenditures (2023 vs 2024 provisional)





Preliminary regional achievements and results

Middle East & Northern Africa



- Multiple emergencies including in Lebanon and the Syrian Arab Republic.
- Approx 1.1 million people provided with healthcare services.
- 533,000 people shelter and housing assistance.

Southern Africa



- Displacement in the eastern Democratic Republic of the Congo & health emergencies
- 461,000 people provided with essential health service.
- Over 1.6 million people provided with protection services.

EHAGL



- Ongoing displacement from the Sudan crisis.
- Over 1.7 million people received non-food items.
- 4.6 million people accessed clean water & sanitation.

Americas



- UNHCR strengthened asylum systems, provided protection, and assisted people displaced by weather disaster and conflict in Brazil, Chile, Colombia, El Salvador, and Haiti.
- Over 370,000 people received essential nonfood items.
- Over 870,000 people benefited from protection services.



Preliminary regional achievements and results

West & Central Africa



- Impact of Sudan crisis in the region
 particularly Chad and Central
 African Republic.
- Healthcare prioritized, with vital services reaching 1.9 million people.
- Over 1.5 million accessed clean water and sanitation.

Europe



- UNHCR continues addressing complex challenges in Ukraine situation.
- Over 1.6 million people received protection services across the region.
- More than 753,000 people received cash assistance, including for winter response in Ukraine.

Asia and the Pacific




- Addressed critical needs in Afghanistan and Myanmar situations.
- Over 2.6 million people received protection services.
- 1.2 million received essential core relief items.





2025 Budget

The 2025 current budget stands at \$10.6 billion





Prioritized strategic targets



13.1 million forcibly displaced supported with protection services.



4.5 million people supported to obtain civil status, identity, or legal documentation to access support services.



3.5 million vulnerable forcibly displacedsupported with cash grants
for immediate needs.



8.3 million vulnerable forcibly displaced receiving emergency relief items.



1.8 million people provided with emergency shelter.



7.1 million forcibly displaced with access to clean water and/or sanitation.



Measures taken to respond and adjust to uncertainty



Reevaluate the feasibility of the planned targets for 2025.



Adjust shifts in funding allocation and prioritize interventions.



Pursue operational and financial efficiency.



Implement specific measures to manage and monitor cash flow.

Core protection interventions safeguarded:

• For 2022 -2025, we maintained investments in these core protection activities at 50% of the needs-driven budget. In 2025, more than 45% of the total needs are currently planned.



OA8: Well-being

More targeted assistance, while advocating for inclusion

• For 2022 – 2024, we gradually improved our targeting and focused the distribution of core relief items and cash on those most vulnerable and in emergencies. Assistance is now planned for those most vulnerable, at only 23% of needs.


Shift towards more sustainable approaches by transitioning from selected sectors

For 2022 – 2024, we worked closely with governments, development actors and sister UN agencies to take on responsibility for health, education and WASH. These investments are now even more limited in 2025, at 33% of total needs.
