Kyiv, Ukraine — Within the span of a week in June, Ukraine's capital witnessed two major aerial attacks; six areas in Kyiv city were impacted, and at least 12 people were killed, including a child, and more than 30 people were injured. UNHCR and NGO partners Rokada and Right to Protection (R2P) provided immediate support, including enrolling affected families for emergency cash assistance, providing legal consultations and psychosocial support. KEY DEVELOPMENTS

- On 20 June, UNHCR and partners commemorated World Refugee Day, including in Ukraine and refugee hosting countries in Europe. Events and exhibitions were held to amplify the challenges faced by people forced to flee worldwide, with participation from refugees and host communities.
- At the 4th Ukraine Recovery Conference in Rome on 10 11 July, EU and international partners pledged over €10 billion to support Ukraine's long-term recovery, launching the European Flagship Fund for Reconstruction to mobilize public and private investment. Humanitarian needs, displacement, and winter preparedness were also discussed, with emphasis on a whole-of-society approach linking development, solutions, and local governance. UNHCR's High Commissioner, Filippo Grandi, and Director of the Regional Bureau for Europe, Philippe Leclerc, were in attendance; in the lead up, UNHCR also issued a press release flagging a new forecasting model and policy brief.
- Major aerial attacks by Russian Armed Forces (RAF) intensified across parts
 of Ukraine, with June seeing the <u>highest monthly civilian casualties</u> in three
 years, with 1,575 casualties (232 killed and 1,343 wounded), and a tenfold
 increase in drone and missiles strikes from June 2024.
- UN HMRRU <u>observed</u> an escalation in civilian casualties and human rights violations in Ukraine amid intensified fighting and evolving tactics of warfare. In its report covering the period from 1 December 2024 31 May 2025, a 37 per cent increase in civilian casualties was observed compared to the same period last year, with 968 killed and 4,807 injured.
- UNHCR's NGO partners continue to respond to people affected by ongoing attacks, including in Sumy City, Kryvyi Rih, Dnipro city and region, Donetska region, Kharkiv, Kirovohrad, Kyivska region, Odesa and Zaporizhzhia. UNHCR partners are providing psychological first aid, emergency shelter material, emergency cash assistance, core relief and essential items, and legal counselling to families affected by recent attacks, complementing the response of local authorities.

- World Refugee Day: UNHCR and partners marked World Refugee Day on 20 June by holding a range of small events across
 the country. On 20 June, local media outlet Pravda also <u>published</u> an op-ed by UNHCR's Representative highlighting the
 power of Ukrainian solidarity and unity.
- Emergency Response: In June, the situation remained volatile in the east of Ukraine, with the frontline in Donetska region continuing to shift and daily shelling observed in frontline communities in Dnipropetrovska, Donetska, and Zaporizka. UNHCR and partners continued to deliver emergency assistance to those affected, responding to more than 95 incidents of shelling/aerial attacks. Partner Proliska supported 637 people with psychosocial support and 447 with protection counselling, while R2P supported 199 people with legal counselling, and 278 with protection counselling. June also saw continued deadly attacks across central and northern regions of Ukraine. In Kyivska region, major attacks between 6 23 June caused heavy residential damage, with a 17 June strike killing 30 and injuring 172. Over 30 buildings were damaged, and over 2,200 people sought help. Partner Rokada provided 169 families with emergency materials for repairs, conducted 211 psychological and 369 social consultations, while partner R2P delivered 30 legal and 30 social consultations.
- Protection: UNHCR recently conducted a four-day training and refresher for 22 focal points and partner organizations covering safety and protection initiatives for women, boys and girls. The training introduced participants to the Women Rise approach, psychosocial support activities within Women and Girls' Safe Spaces and transformative environments where women can explore belonging, personal power, emotions, and self-expression. The workshop also served as an opportunity to review the classification tool and strengthen participants' capacities in case management, with a focus on supporting survivors of conflict-related sexual violence and individuals from minority communities.
- Housing/Shelter: As part of UNHCR's efforts to enhance the thermal efficiency of houses and collective sites, in June new
 windows were installed in 18 households in Dnipropetrovska region, 100 households in Zaporizka region and one of the
 collective sites in Dnipropetrovska region. So far this year, nearly 70,000 people received emergency shelter and housing
 support from UNHCR and partners.
- Cash assistance: From January May 2025, UNHCR delivered cash assistance to more than 69,660 people totalling more
 than \$21.4 million to help cover the costs of basic needs like accommodation, food, medicine, clothing, and heating. This
 includes almost 35,700 vulnerable people who were assisted because they were either in need of urgent support following
 aerial attacks or evacuation, were recently displaced within the last six months, or are returnees who are socioeconomically
 vulnerable and have specific protection needs.

Shelter support for war-affected people in Ukraine





Rivne, Ukraine – Nataliia, 56, and Hennadii, 55, were displaced from their home in Kharkiv, northeastern Ukraine when the full-scale invasion started in 2022, finding safety in Rivne region in the country's west. With them, they brought a set of plates and cups to remind them of their lives before the war. The rural house they moved into was in poor condition. UNHCR through NGO partner Rokada supported them by with roof repairs. UNHCR is helping internally displaced people with repair works such as replacement of windows and doors, insulation of houses and roofing work, to support internally displaced and war-affected people.



^{**}As of mid-June 2023 an estimated 1.2 million Ukrainians were recorded in the Russian Federation under different legal forms of stay (other than refugee or temporary asylum status) and reported by UNHCR as persons in a refugee-like situation. - Belarus: UNHCR's Representative undertook a mission to Vitebsk, northeast Belarus during which he met with the administration of the Temporary Accommodation Centre (TAC) in Vitebsk, currently undergoing renovation. As part of the mission, the Representative visited TAC's sports ground which has been maintained through UNHCR's support, and attended the handover for housing equipment.
- Bulgaria: On 10 June, UNHCR officially launched the <u>Harmanli Compass Protection and Inclusion Centre</u>, the seventh centre in the Compass Network across seven refugee-hosting cities in Bulgaria. UNHCR and partner Bulgarian Red Cross jointly organized a roundtable with regional authorities for education, social assistance, and employment as well as civil society members to mark the occasion.
- Czechia: UNHCR published its Czechia Protection Brief in June, based on 435 protection monitoring interviews
 conducted across 14 regions. The brief highlights the situation of vulnerable refugees from Ukraine. In response, partner
 SIMI conducted an information campaign, while OPU lawyers provided individual legal assistance, including one case
 that was referred to the Ombudsman.
- Hungary: On 19 June, UNHCR partner Hungarian Interchurch Aid organized a roundtable focusing on access to decent
 work for refugees from Ukraine, as well as violence in the family. Discussions on employment covered legal status, recognition of qualifications, and the categories of jobs sought by refugees. The session on violence amongst close relatives
 highlighted shrinking support for victims and emerging forms of violence linked to the impacts of war.
- Poland: In June, UNHCR visited eight Border Crossing Points (BCPs) in the Podkarpackie and Lubelskie regions to assess
 movement trends, arrival profiles, and any procedural changes. According to BCP data, arrivals to Poland increased by 11
 per cent compared during the month compared to May.
- Moldova: Starting end-June, UNHCR restructured its operational presence in Otaci along the MOL-UKR border to reflect
 the stabilized situation. The Border Reception Centre was formally closed, and UNHCR infrastructure (office and storage
 units) were relocated to nearby school facilities, which also host the municipality's social services. Partners ACTED and
 Law Center of Advocates continue activities from this integrated hub. A contingency preparedness workshop with local
 authorities is scheduled for July to develop a rapid reactivation plan for Otaci, to be aligned with UNHCR's national contingency planning.
- Romania: On 20 June, UNHCR conducted a monitoring visit to the General Directorate of Social Assistance and Child Protection (DGASPC) Sector 2 in Bucharest to observe access to services, benefits, and child protection support for Ukrainian refugee children. The visit highlighted the need to improve language support and ensure sustained access to specialized services. UNHCR will continue working with DGASPC Sector 2 to strengthen protection and assistance for refugee children, with a focus on the most vulnerable cases.
- **Slovakia:** On 11 June, UNHCR in collaboration with the Union of Cities delivered a training on protection from sexual exploitation and abuse (PSEA) for municipal-led Point of Safety centers and other municipal staff, to ensure alignment with the minimum common standards under the Point of Safety Network.

World Refugee Day Commemorations in Moldova





Chisinau, Moldova – On World Refugee Day (20 June), UNHCR launched a children's book written by Yuliia Ivashutkina, a refugee author from Ukraine, and illustrated by Ivanka Costru, a Moldovan artist specializing in children's books. Children listened to the story read by the author herself, then brought it to life with colours — sparking imagination, empathy, and connection among participants.

BASIC NEEDS & WELL-BEING

- Belarus: So far in 2025, UNHCR provided cash assistance to 189 households, encompassing a total of 454 individuals
 who arrived in Belarus from Ukraine. This represents approximately 57 per cent of the planned 800 individuals from
 Ukraine targeted for cash assistance in 2025.
- Poland: In anticipation of the upcoming closure of its warehouse, UNHCR is finalizing distribution of non-food items (NFIs) from emergency stocks to social welfare centers in Wesola and Jozefow (near Warsaw), as well as the Volunteer Fire Department Association, and the Mountain Volunteer Search and Rescue. UNHCR is also planning a delivery of 1,900 NFIs for the Roma community in Jazowsko, southern Poland, in collaboration with partner Towards Dialogue.
- Romania: On 30 June, UNHCR completed the physical transfer of its contingency stock of core-relief items (CRIs) to
 the Ministry of Interior's Department for Emergency Situations (DSU), which concluded with the vacating and closure of
 UNHCR's warehouse. In total, 208,542 CRIs were donated. The transfer is part of UNHCR efforts to reduce its operational
 footprint and warehousing costs.
- Russian Federation: In June, 1,007 refugees from Ukraine were counselled in person by UNHCR and partners in urban
 areas, while 939 were counselled in the border regions of Voronezh, Kursk, Rostov-on-Don, Bryansk and Belgorod. A
 total of 3,298 refugees were counselled via the hotline by UNHCR and partners in May.

SOCIO-ECONOMIC INCLUSION & LOCALIZATION

18,900 people reached with socio-economic inclusion services so far in 2025, including livelihoods support by UNHCR and partners, out of a goal of 77,200

- Bulgaria: The final training sessions of the Academy for Refugee Teachers—UNHCR's flagship programme for education—took place in June. The final event's theme was "Creating an Inclusive School Environment" and focused on developing school-wide inclusion policies with participation from parents. The Academy, organized with the support of the Ministry of Education and Science, is a year-long capacity building programme for schoolteachers who have refugee pupils and focuses mainly on teaching Bulgarian as a foreign language, while touching on inclusive education and trauma-informed teaching. 69 teachers from more than 40 municipal kindergartens and schools participated.
- Czechia: From 19 20 June, UNHCR in partnership with the Office of the Government and UNICEF, organized a two-day Youth Forum Conference in Prague, bringing together 13 young Ukrainian refugee leaders (aged 14 24). Activities included a meeting with the Human Rights Commissioner, a guided visit to the Parliament, and a Virtual Reality workshop led by UNHCR. Over 60 participants attended the main conference, where youth presented community-based initiatives. The event also served to commemorate World Refugee Day, promoting inclusion and solidarity.
- Moldova: In June, UNHCR launched a new academic grants program under the Sergio Vieira de Mello Academic Chair (SVMC) initiative. The grants are available to students and faculty members from SVMC member institutions to support research, education, and community outreach on issues related to forced displacement, with the goal of fostering evidence-based policy recommendations, and stronger ties between academia and refugee communities.
- Romania: On 24 June, UNHCR, together with the National Agency for Equal Opportunities for Women and Men (ANES) and an independent trainer, held a one-day session on Empowerment through Self-Defense at RomExpo Community Centre in Bucharest. The training focused on improving self-awareness of the Ukrainian female participants. UNHCR and ANES will conduct an further session on violence in the family later this summer. Since the beginning of the year, UNHCR supported 1,705 people through specialized victim and survivor-centred services.
- **Slovakia:** On 20 June, on the occasion of World Refugee Day as well as Olympic Day, UNHCR in cooperation with the Slovak Olympic and Sports Committee and NGO People in Peril, officially launched the multi-year project 'United in Sport', funded by LivGolf. The initiative aims to enhance inclusion for refugee children and youth through inclusive sport activities in Slovak schools, with participation from host community members. Around 500 children from primary schools in Bratislava participated in the sports activities.

COORDINATION

UKRAINE

In Ukraine, UNHCR leads three Clusters, namely Camp Coordination and Camp Management (CCCM), Protection, and Shelter and Non-Food Items (NFIs). The CCCM Cluster was activated in March 2022 and coordinates 32 UN and NGO partners across three coordination hubs, with the goal of supporting 149,000 people in collective sites in 2025. The Protection Cluster consists of 88 partners, including sub-clusters, and operates three coordination hubs to reach an anticipated three million people in 2024. The Shelter and NFI Cluster coordinates 157 partners across three coordination hubs, with the goal of reaching 3 million people with NFI kits, emergency shelter and housing repairs. UNHCR also co-chairs the Protection Strategy Working Group under the Humanitarian Country Team, and the Accountability to Affected Populations (AAP) Working Group. Through its leadership in these areas, UNHCR promotes the centrality of protection, as well as meaningful engagement and participation across the response.

REGIONAL REFUGEE RESPONSE

UNHCR leads and coordinates the 2025-2026 Regional Refugee Response Plan (RRP), bringing together 266 partners in Belarus, Bulgaria, Czech Republic, Estonia, Hungary, Latvia, Lithuania, Poland, Republic of Moldova, Romania and Slovakia in support of the government-led response efforts. Partners work towards ensuring refugees have effective access to legal status, protection and rights in their host countries and that refugees with specific needs and vulnerabilities have access to tailored support and assistance. The plan also seeks to strengthen refugees' socio-economic inclusion in their host communities and increase their self-reliance, while reinforcing social cohesion between refugees and their hosts. Through the coordinated plan, partners are advancing the localization of the response by supporting national and local civil society, municipalities, local authorities and coordination structures.




