Background	The SAFE Access to Fuel and Energy Plus (SAFE+) program was conceived in 2018 in response to the massive influx of 700,000 Rohingya refugees to Cox's Bazar, Bangladesh, which led to the creation of the world's largest refugee settlement spanning 33 camps. This sudden influx placed severe strain on the region's fragile resources and ecosystems, including 2,500 hectares of protected forest allocated by the Government of Bangladesh. Immediate impacts included deforestation, soil erosion, and increased carbon emissions due to the daily requirement of 900,000 kilos of firewood for cooking, leading to significant environmental degradation and health issues for refugees.
	To address these challenges, UN agencies, in collaboration with donors and the Government of Bangladesh, launched the SAFE+ program (2019–2022), which significantly improved livelihoods, reduced environmental damage, and regenerated thousands of hectares of forest. SAFE+ 2 (2022–2025) builds on these successes with a focus on three integrated areas of intervention.
	This Mid-Term Evaluation aims to generate evidence on the programme's outcomes and impacts and guide the remainder of the programme's implementation period. The generated information is foreseen to provide actionable advice to the programme's key stakeholders and to guide similar (future) initiatives to achieve sustainable results. The main objective of this evaluation is to evaluate the programme's performance against the desired results articulated in the foundational programme document and Result Framework.

Overall Comments: [Any general comments on the evaluation findings and recommendations and HC/HCT's approach to address its recommendations]

The SAFE+2 program partners have reviewed and discussed the recommendations from the midterm evaluation. Specific actions have been identified to address the evaluation recommendations, and improvement actions are already been implemented.

As a joint program, the evaluation process was designed to foster collaboration and shared accountability among all four partners. However, the Terms of Reference (ToR) did not specify any particular quality assurance procedures or mandate a formal management response. Instead, the evaluation's primary utility lies in facilitating discussions among partners based on the recommendations provided.

As the convening agency for SAFE+2, UNHCR administered the available funding for the evaluation through its coordination role. However, the evaluation should not be considered a UNHCR-led initiative.

Moving forward, the program partners aim to ensure that the evaluation findings are used effectively to guide program improvements while maintaining the collaborative spirit of the initiative.

Recommendation 1: Contingency Plans and exit strategy: Conduct a risk analysis of the project to identify risks and scenario planning, especially regarding funding reduction, assess their severity, and develop mitigation measures. Establish a contingency mechanism to address unforeseen challenges, with regular revisions as needed to adapt to evolving circumstances and funding landscape. Sustain and diversify funding sources, maintaining a balance between addressing immediate humanitarian needs and long-term developmental concerns. Develop an exit strategy, particularly for strategic priority 1: provision of clean cooking energy.

Develop livelihood activities tailored for refugee women to be implemented at the family and block levels within the camps, enhancing their empowerment, safety and reducing social stress.
