Operational Context

India continues to be a generous host to refugees and asylum-seekers from across the region and beyond. UNHCR works in close coordination with the Government of India, NITI Aayog and other UN agencies in fulfilling its mandate of ensuring access to protection, solutions, and humanitarian assistance to persons forced to flee.

Civil society organizations, working in partnership with UNHCR, are at the forefront of the refugee response ensuring that assistance reaches the most vulnerable within the overall objective of “leaving no one behind”. Partnership agreements are in place with eight national NGOs.

To ensure that refugees are included in the UN's work on Sustainable Development Goals, UNHCR maintains close engagement with the UN Country Teams in India and the Maldives. In 2025, resilience building, and self-reliance remain top priorities in furthering UNHCR's efforts to support refugees and asylum seekers.

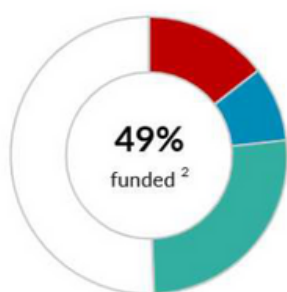

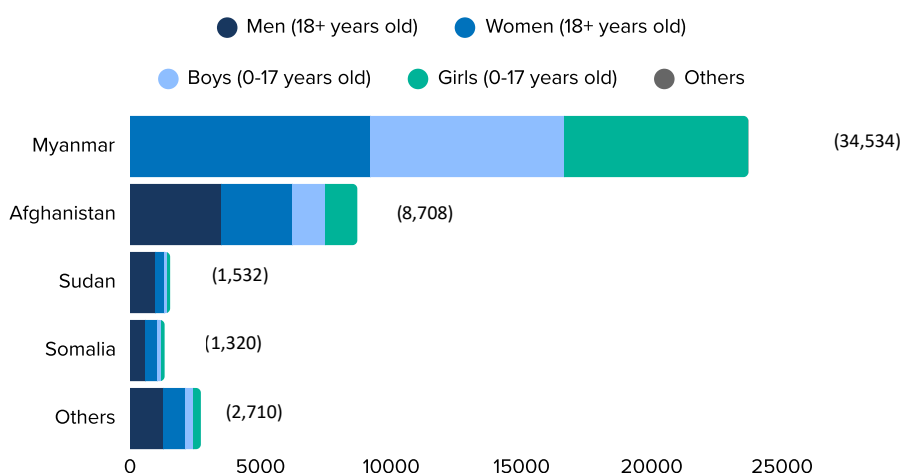

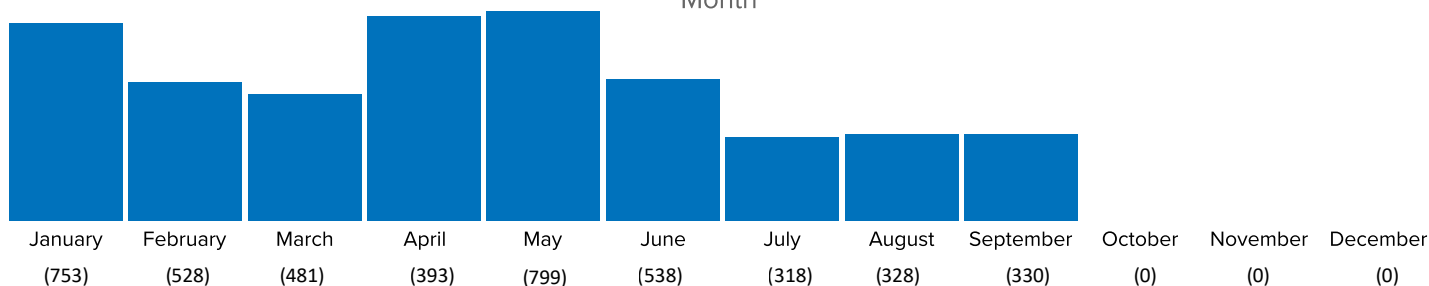

A Taste of Hope:

Livelihood opportunities are helping Rohingya youth build new futures

A livelihood initiative in Nuh is helping Rohingya refugee youth gain dignity, identity and hope through meaningful work.

“Cooking gives me identity.” For 24-year-old Abdul Rehman, these words reflect not just his love for preparing food, but the sense of purpose he has discovered at Sufra Restaurant along the Nuh–Alwar highway. Known across the Mewat region for its flavourful dishes and warm service, Sufra is also where young Rohingya refugees are rebuilding their lives through opportunity and trust. Since 2021, 13 refugee youth have been employed here through UNHCR’s livelihood programme in Nuh, facilitated by the implementing partner Action Aid, turning the restaurant into a pathway to dignity.

Abdul arrived in India in 2013 and proudly calls himself a chef — a role that strengthens his confidence and identity. His journey mirrors that of other refugee youth at Sufra. Jahangir, who fled Myanmar at the age of 12, works tirelessly in the kitchen and uses most of his modest income to support his ailing father, despite living with the constant fear of detention. His wife, Zuhara, separated from her family for seven years after arriving as a minor, hopes for safety and continuity for their children.

For Shahid Noor, a father of three, work at Sufra brings stability and pride as his children attend school. With UNHCR’s support, refugee youth at Sufra are gaining skills, confidence and independence — demonstrating that when refugees are given opportunity, they contribute and strengthen the communities around them.
