INTRODUCTION

1. Countries contribute in different ways to the international regime of protection and assistance to refugees and to the provision of durable solutions. Countries neighbouring refugee-producing areas often provide temporary asylum to large groups of refugees. Some of these asylum countries allow refugees to become self-reliant by providing them with land or employment opportunities. While a significant share of the costs of hosting large refugee populations is borne by the asylum countries, high-income countries support refugee programmes in developing countries to reduce this burden. A number of developed countries support the international protection regime by providing resettlement opportunities to refugees from first asylum countries. Moreover, many developed countries receive a significant number of asylum-seekers each year. The international refugee protection regime, supported by UNHCR, has as one its goals to ensure that refugee protection and assistance is shared equitably among states.
2. This purpose of this report is to provide basic statistics that help measure the burden shouldered by host countries caring for refugees and displaced persons. In total, more than 160 countries and territories are included in the analysis. Rather than a final report, this study should be considered as a first step. Comments and suggestions are most welcome.

METHODOLOGY

3. This report is based on three core statistics available to UNHCR: (a) the refugee population, (b) the total population of concern to UNHCR and (c) the number of asylum applications submitted during 2000. These three data elements have been selected because they reflect the number of persons in state of displacement and/or in need of international protection.
4. Total refugee population, end-2000. This includes UNHCR's best estimate of the size of the total refugee population in each country. In industrialized countries without a reliable source to estimate the refugee population, the figures have been estimated by UNHCR, based on recent refugee arrivals (resettlement) as well as recognition of asylum-seekers. The refugee estimates for Australia, Canada, New Zealand and the USA are based on the refugee arrivals and asylum-seeker recognition over the past five years, whereas for European countries a cut-off of period of ten years has been applied. This difference reflects the different pace in naturalization in these two groups of countries.
5. Total population of concern to UNHCR, end-2000. This includes asylum-seekers, refugees and others of concern to UNHCR, refugees who have recently returned to their countries as well as internally displaced under UNHCR's care. It should be stressed that only a small part of the world's internally displaced are protected or assisted by the Office.
6. Asylum applications submitted during 2000. Many countries, particularly those located in the developed world, receive significant numbers of asylum-seekers, i.e. persons whose claim for refugee status needs to be determined. The data presented here include both applications submitted to Governments under the 1951 Convention as well as claims submitted to UNHCR for determination under its mandate.

7. These three core statistics have been compared with three additional indicators, (a) national population size, (b) Gross Domestic Product and (c) national surface area. These indicators were chosen both of their relevance to the absorption capacity of countries and because they are available for most countries included in this analysis. On the other hand, expenditure on asylum and refugees, while a key indicator for “burden sharing”, has not been included due to the difficulties in quantifying and comparing national financial contributions.

8. Gross Domestic Product (GDP). The GDP is one of the most basic and widest available measurements of a country’s wealth. As such, it is a primary indicator of the ability of countries to support displaced persons. The GDP figures used in this document reflect the most recent estimates by the World Bank¹.

9. National population size. It is sometimes argued that the ability of host countries to absorb refugees and displaced persons is also a function of national population size. Asylum-seekers and refugees are likely to integrate more easily in a large rather than in a small host population. Often, refugees tend to live in confined areas such as camps, significantly increasing the burden on the host area as compared to the rest of the country. However, as the scope of the current study is limited to the national level, such regional differences, although significant, are not taken into account. The national population size used in this document is based on the medium variant of the 2000 estimates of the United Nations Population Division².

10. National surface area. In some countries, access to land is an important means for refugees to sustain their families. It may be argued that larger countries have less difficulty in hosting refugees than smaller countries³. Clearly, this is only a rough assessment considering that the nature of the terrain or the quality of land are not taken into account.

11. In Table 1, UNHCR statistics are provided for all 160 countries and territories (“UNHCR indicators”). The second set of indicators in the table (“Per 1,000 inhabitants”) calculates the number of refugees, total persons of concern and asylum applications per 1,000 inhabitants. In Armenia for instance, there are 74.1 refugees for every 1,000 inhabitants. The third set of indicators (“Per 1 mln. GDP (USD)”) calculates the number of refugees, total persons of concern and asylum applications per 1 million of GDP. In Armenia for instance, there are 147 refugees for every million Gross Domestic Product (USD). Finally, the fourth set of data calculates the number of refugees, total persons of concern and asylum applications per 1,000 square kilometres. In Armenia for instance, there are, on average, almost 10 refugees per square kilometre. The higher the value of each of the above calculated indicators, the higher the “refugee burden” is on the country.

12. In Table 2, countries are ranked according to the indicators provided in Table 1. For instance, Armenia, which hosts the 11th highest refugee population in absolute terms, ranks first when comparing the refugee population with the size of the national population, the GDP and the national surface area. The higher the rank, the “refugee burden” is on the country.

13. Table 3 shows the total of the ranks of all countries listed in Table 2. Table 4 lists, for each of the 12 indicators provided in Table 1 and ranked in Table 2, the 20 main countries and their values. Tables 5 through 8 provide an analysis of the data for major regional groupings, including for the Least Developed Countries (Table 5), the OECD member countries (Table 6), various other country groupings (Table 7) as well as the UN major areas and regions (Table 8).

14. GPD per capita. Considering the importance of GDP as the main indicator for host countries to support refugees and displaced persons, the second part of the paper compares the three UNHCR statistics with the GDP per capita (Tables 9 to 14).

MAIN CONCLUSIONS

15. Table 3 provides the top 20 countries for the 12 indicators provided in Tables 1 and 2. Pakistan and the Islamic Republic of Iran host the largest number of refugees and persons of concern, whereas Iran also processed the largest number of individual asylum applications. Compared with the national population, the countries ranking the highest are Armenia (refugee population), Eritrea (total population of concern) and Slovenia (asylum applications). Compared with the GDP, the top ranking countries are Armenia (refugee population), Eritrea (total population of concern) and Central African Republic (asylum applications). Lastly, compared with the national surface area, the main countries are Armenia (refugees), Bosnia and Herzegovina (total population of concern) and Belgium (asylum applications).

16. When the rankings of the indicators of Table 2 are combined, the Islamic Republic of Iran has the highest “burden” of all countries, followed by Burundi, Guinea, the United Republic of Tanzania and Gambia (Table 4).

17. The preponderance of African countries at the top of Table 4 is significant. Countries in Sub-Saharan Africa could be expected to rank high when comparing the UNHCR data with GDP; however, their relatively high refugee burden compared to the size of the national population and surface area is an important outcome of this analysis.

18. The Least Developed Countries (LDCs) have significantly higher ratings than the non-LDCs when the refugee burden is compared with the GDP. Remarkably, however, LDCs also score higher than non-LDCs in the number of refugees and persons of concern per 1,000 inhabitants, as well as in the number of refugees and persons of concern per 1,000 km² (Table 7).

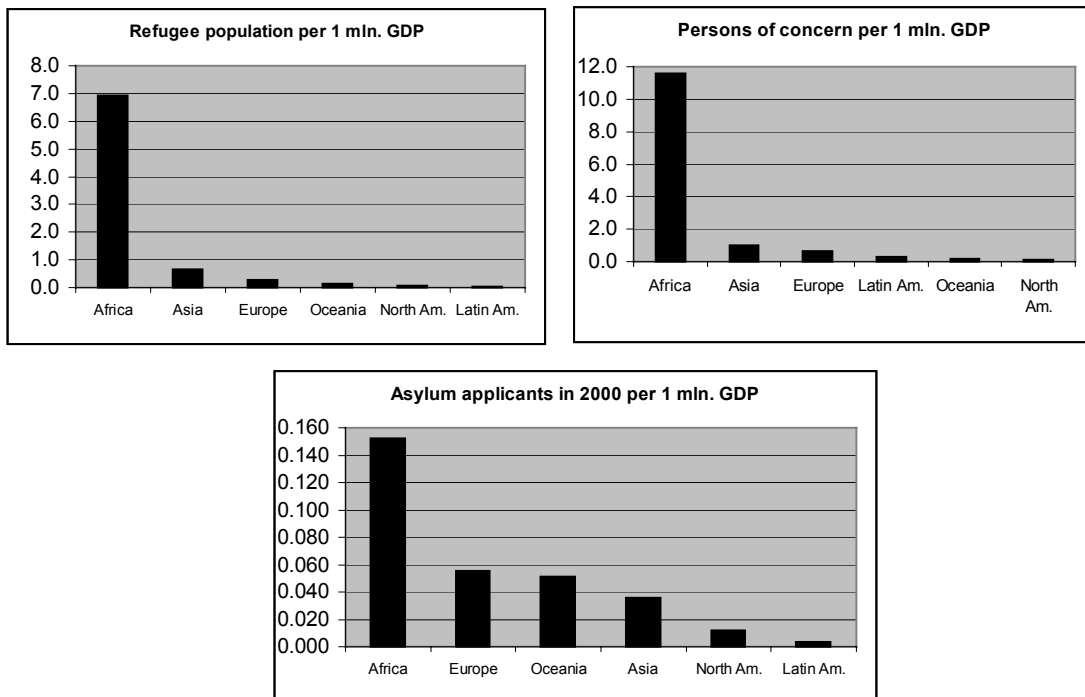
19. Non-OECD countries rate higher than OECD countries for six of the nine indicators. However, OECD countries score significantly higher than non-OECD countries on the indicators “Asylum applications lodged in 2000 per 1,000 inhabitants” and “Asylum applications lodged in 2000 per 1,000 km²” (Table 7).

20. Sub-Saharan Africa scores high on most indicators, a reflection of the region’s important role in today’s international refugee programmes. However, the fact that most indicators for Sub-Saharan Africa are slightly lower than for the LDCs in general is a reminder that the refugee issue is not limited to the African continent only (Table 7).

21. The analysis by national income broadly supports the above trends. Low income countries score not only high in comparing the refugee burden with GDP, but also in comparison with the national population and the surface area. Out of the nine indicators, low income countries score the highest on six, whereas high income countries score the highest on the other three variables. Surprisingly, the lower and upper middle income countries do not score the highest on any of the nine variables, suggesting that the refugee burden is mostly an issue between the poorest and the richest countries (Table 7).

22. This outcome is broadly corroborated when looking at the Human Development Index, a composite indicator designed by the UN Development Programme, measuring human development in its broadest possible sense. States classified as having the lowest human development, score the highest on seven out of the nine indicators of the refugee burden, whereas countries with the highest human development score highest only twice, each time in relation to the number of asylum applications lodged. Countries ranked as having a medium human development did not score the highest on any of the nine indicators (Table 7).

23. Compared with the national population, the refugee burden of Eastern Africa, Middle Africa and Western Europe is three times higher (6.4-6.8) than the global average (2.0). Eastern Africa and Southern Europe host more than 12 persons of concern to UNHCR per 1,000 inhabitants, more than three times the global average (3.6). As could be expected, Africa has by far the highest refugee burden when compared with GDP (see charts below).



24. When the total surface of the country is considered, the highest number of refugees, persons of concern and asylum-seekers is found in Southern and Western Europe (Table 8).

25. Tables 9 through 14 are devoted to the GDP per capita in relation to the three UNHCR variables for displacement.

26. Countries with the highest refugee population compared to GDP per capita are Pakistan, United Rep. of Tanzania and the Democratic Republic of the Congo (DRC). In addition to the ranking, the differences in the value of the ratio between the countries should be noted. Thus, the refugee burden in Pakistan expressed by this ratio (4,600) is almost double the burden of Tanzania, the second highest ranking country (2,600), and seven times the burden faced by Kenya, the number ten on the list (610). The first industrialized country on the list is Germany, ranking 37th (Table 9).

27. Countries hosting the highest total population of concern to UNHCR compared to their GDP per capita are Eritrea, Pakistan and Sierra Leone. Again, the differences in the ratio between countries is significant. For instance, the burden in Pakistan (4,600) is 180 times higher than that of the USA (26). The first industrialized country (Germany) ranks 48th (Table 10).

28. Host countries with a low economic or social development have by far the highest ratio of refugees and displaced persons compared to their GDP per capita. The most extreme example are the low income countries where the ratio refugees/GDP per capita (14,700) is more than 150 times higher than for the high income countries (90) (Table 13).

29. Eastern Africa and South-central Asia are regions with the highest displacement burden compared to their GDP per capita (Table 14).

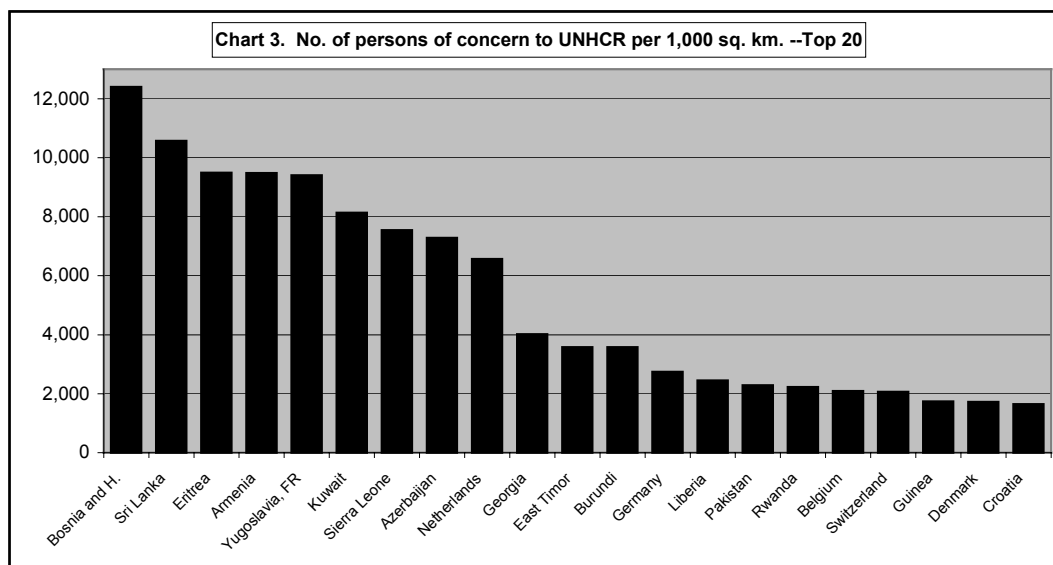
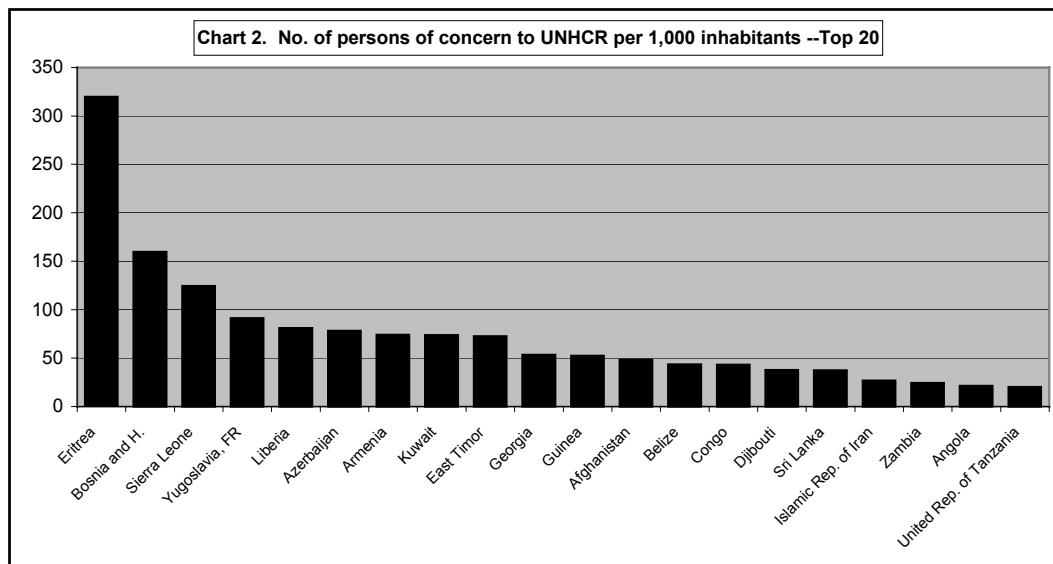
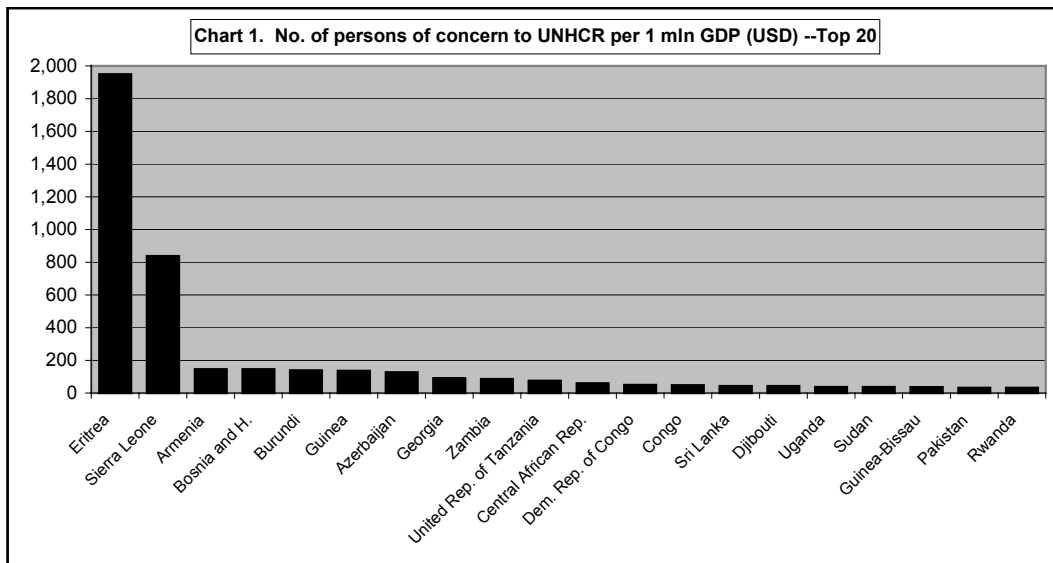
