UPDATE ON PROGRAMME BUDGETS AND FUNDING IN 2007 AND 2008, INCLUDING A PROPOSAL FOR AN INCREASE TO THE 2008 ANNUAL PROGRAMME BUDGET

I. INTRODUCTION

- 1. At the 41st meeting of the Standing Committee in March 2008, UNHCR presented preliminary income and expenditure figures for 2007, as well as overall programme budget and funding projections for 2008 (document EC/59/SC/CRP.6 refers). The present document provides final expenditure figures for 2007 (Annex I), as well updated information on programme budgets and funding in 2008 (also in Annex I); lists of transfers from the 2008 Operational Reserve and from the 2008 "New or additional activities-mandate-related" Reserve (Annexes II and III respectively); a list of overall contributions in 2008 (Annex IV) as of end May; and a breakdown of contributions by non-governmental organizations (NGOs), foundations and private donors (Annex V).
- 2. Also included in this document is a proposal for an increase in the 2008 Annual Programme Budget to a level of \$1,173.2 million. Finally, a draft decision on overall programme budgets and funding for 2008 is proposed in Annex VI.

II. INCOME AND EXPENDITURE IN 2007

- 3. Total funds available for 2007 amounted to \$1,459.9 million, including a carry-over of \$121.0 million. Under the Annual Programme Budget, funds available amounted to \$1,085.2 million, comprising \$972.6 million in contributions, a carry-over from 2006 of \$65.6 million and miscellaneous income and adjustments amounting to \$47.0 million. Of the total funds available, \$1,031.4 million was under the Annual Budget, \$37.0 million under the United Nations Regular Budget and \$16.8 million for the Junior Professional Officers (JPOs). Total funds available under Supplementary Programme Budgets amounted to \$374.7 million, including a carry-over from 2006 of \$55.4 million.
- 4. Total expenditure in 2007 amounted to \$1,342.0 million (Annex I, column 1). Of this amount, the Annual Programme Budget accounted for \$1,015.9 million, including \$37.0 million under the United Nations Regular Budget and \$9.6 million for JPOs. Total expenditure under the Supplementary Budgets was \$326.1 million. In comparison to 2006, expenditure in 2007 under the Annual Programme Budget increased by \$111.2 million, reflecting a higher level of available funds.

- 5. The 2007 Annual Programme Budget closing balance was thus \$69.3 million, which was \$3.7 million higher than in 2006. This closing balance comprised \$62.1 million under the Annual Programme Fund and \$7.2 million under the JPO Fund. The 2007 closing balance for Supplementary Programme Budgets was \$48.6 million. In January 2008, \$5.8 million was transferred from the Supplementary Programmes Fund to the Annual Programme Fund since the Supplementary Programme for the Pakistan Cyclone and Floods Emergency came to an end and the Supplementary Programme for the Repatriation and Reintegration of Congolese (DRC) Refugees was mainstreamed in 2008, leaving a balance of \$42.8 million available for use under the relevant 2008 Supplementary Programmes (Annex I, column 5).
- 6. UNHCR again benefited from favourable foreign exchange rate movements in 2007. The benefits were realized against both the budget rates and contributions received for 2007. Thus, on the income side, a net gain of \$6.1 million was recorded. The High Commissioner has therefore added this amount to the \$23.7 million buffer established in 2007 against possible foreign exchange losses so as to ensure that income fluctuations due to exchange rate movements do not have a negative impact on the funding of programmed activities for refugees.

III. UPDATE ON PROGRAMME BUDGETS AND FUNDING FOR 2008

7. Total budgets for 2008 currently amount to \$1,667.7 million (Annex I, column 3), comprising \$1,096.1 million under the Annual Programme Budget and \$571.6 million under 22 Supplementary Programme Budgets, including 10 exclusively for internally displaced persons (IDPs).

A. The 2008 Annual Programme Budget

- 8. At its 58th session in October 2007, the Executive Committee approved programmed activities under the 2008 Annual Programme Budget of \$919.2 million (Annex I, column 2), including an allocation of \$34.8 million from the United Nations Regular Budget. Additional provisions of \$91.9 million and \$75 million were approved respectively under the Operational Reserve and the "New or additional activities mandate-related" Reserve. The Executive Committee also took note of the \$10 million in budgeted activities for JPOs, bringing total requirements to \$1,096.1 million (A/AC.96/1048). As of 30 April 2008, estimated expenditure stood at \$323.2 million (Annex I, column 4).
- 9. Transfers from the 2008 Operational Reserve up to 31 May 2008 amounted to \$70.1 million, as shown in Annex II. Transfers from the "New or additional activities mandate-related" Reserve amounted to \$48.8 million, as shown in Annex III. Thus, as of 31 May 2008, the balance under the 2008 Operational Reserve stood at \$21.8 million and at \$24.0 million under the "New or additional activities mandate-related" Reserve (after deduction of \$2.2 million corresponding to the overhead charge of 7 per cent).
- 10. With \$818.8 million received in contributions as of 31 May 2008 (including \$33.8 million from the United Nations Regular Budget, \$35.2 million under the "New or additional activities mandate-related" Reserve and \$3.3 million under the JPO Fund) and a carry-over from 2007 of \$69.3 million, total funds available under the Annual Programme Budget as of 31 May 2008 stood at \$881.1 million. Including the mainstreaming of \$5.8 million from two 2007 Supplementary Programme Budgets into the 2008 Annual Programme Budget, UNHCR

currently hopes to receive further income of \$257.6 million, leaving a projected surplus of \$49.6 million (Annex I, column 10).

B. Proposed increase to the 2008 Annual Programme Budget

- 11. In early 2007, UNHCR established guidelines, priorities and goals for the 2008-2009 Biennial Programme Budget process, which included a review of the Office's fiscal status and projected income and expenditures for the coming years. Over a year has passed since the initial planning assumptions were established and the budget rates were set. Since then, income and expenditure targets and the underlying basis for calculating the budgets for existing personnel costs have changed.
- 12. In particular, the significant decline in the relative value of the US dollar to most other currencies has led to a situation where the budget rate set in March 2007 for non-US dollar currencies no longer corresponds to the prevailing market rates. UNHCR therefore plans to selectively adjust the budget rates for non-US dollar currencies in line with current programme objectives and priorities.
- 13. In order to create the additional budgetary space required to absorb some of the budgetary exchange rate losses and to be able to respond to further emergencies, the mechanism being proposed is to reconstitute the Operational Reserve at the full 10 per cent of current programmed activities, i.e. those originally approved by the Executive Committee plus the Operational Reserve allocations of \$70.1 million made to date. The following table illustrates this proposal:

14. While UNHCR does not expect to receive additional income up to the full level of the proposed budgetary increase, the new level would provide the organization with the budgetary space needed to selectively mitigate the impact of exchange rate movements against the budget rate, while preserving the flexibility to select the most appropriate course of action in response to changing requirements.

C. 2008 Supplementary Programme Budgets

15. Since the approval of the Annual Programme Budget for 2008, 22 Supplementary Programme Budgets have been approved, including 10 exclusively for IDPs, bringing the current total budget for 2008 Supplementary Programmes to \$571.6 million (Annex I, column 3). With an available carry-over from 2007 of \$42.8 million and \$315.7 million so far received in contributions, \$358.5 million were available as of 31 May under the 2008 Supplementary Budget Programmes. Additional projected contributions and adjustments amount to \$52.3 million, leaving a budgetary shortfall of \$160.8 million. Estimated expenditure stood at \$96.1 million as of 30 April 2008.

Annex VI

DRAFT DECISION ON OVERALL PROGRAMME BUDGETS AND FUNDING FOR 2008

The Standing Committee,

Recalling the Executive Committee's decision at its fifty-eighth session on administrative, financial and programme matters (A/AC.96/1048), as well as its discussions under the programmes, budgets and funding item at the forty-first meeting of the Standing Committee,

Reaffirming the importance of international burden and responsibility-sharing in reducing the burden on countries hosting refugees, especially developing ones,

- 1. Recalls that the Executive Committee, at its fifty-eighth session, approved UNHCR's 2008 Annual Programme Budget at a level of \$1,096.1 million (which included \$34.8 million from the United Nations Regular Budget and \$10.0 million for Junior Professional Officers);
- 2. *Notes* that exchange rate fluctuations, emergencies and unforeseen activities have increased UNHCR's 2008 budgetary requirements;
- 3. *Approves* an increase to UNHCR's 2008 Annual Programme Budget amounting to \$77.1 million, thereby bringing the revised 2008 Annual Programme Budget to a level of 1,173.2 million (including \$34.8 million from the United Nations Regular Budget and \$10.0 million for Junior Professional Officers);
- 4. *Notes* that the 2008 Supplementary Programme Budgets currently amount to \$571.6 million, including \$120.8 million for programmes exclusively benefiting internally displaced persons (IDPs);
- 5. Recognizes that emergencies and unforeseen activities unfolding in 2008 may result in the need for additional or expanded Supplementary Programmes and that additional resources, over and above those for existing budgets, would be needed to meet such needs; and
- 6. *Urges* Member States, in light of the extensive needs to be addressed by the Office of the High Commissioner, to continue to respond generously and in a spirit of solidarity, and in a timely manner, to his appeal for resources to meet the requirements under both the revised 2008 Annual Programme Budget as well as the 2008 Supplementary Programme Budgets.
