I. Introduction

1. At its seventieth session in October 2019, the Executive Committee adopted a decision which set out the issues to be examined by the Standing Committee in its programme of work for 2020.¹ This report provides a summary of the implementation of this programme.

2. The Standing Committee held three meetings in 2020: in March, July and September. A planning meeting of Executive Committee members in December 2019 established the calendar of meetings and determined the distribution of the agenda items in 2020. This is provided in the work programme contained in annex I.

3. A detailed account of the work undertaken at each meeting of the Standing Committee in 2020 is contained in the following documents: the report of the seventy-seventh meeting of the Standing Committee (A/AC.96/1199); the report of the seventy-eighth meeting of the Standing Committee (A/AC.96/1206); and the report of the seventy-ninth meeting of the Standing Committee (A/AC.96/1207). A list of conference room papers, strategic overviews and other documents considered at these meetings is contained in annex II.

II. Issues considered by the Standing Committee in 2020

A. Programme budgets and funding

4. At each of its meetings, the Standing Committee considered updates on budgets and funding, through which it was kept informed of programme requirements, budgetary measures and funding levels. The Committee also adopted decisions on budgets and funding, as listed in chapter III below. In March, the Standing Committee was briefed on UNHCR's reserves as of 2022, and in July, UNHCR's Global Report on activities in 2019 was presented. At its September meeting, the Committee reviewed the revised biennial programme budget for 2020-2021, together with the report of the Advisory Committee on Administrative and Budgetary Questions (ACABQ),² and also considered UNHCR's new planning, budgeting and monitoring system (an item which was added to the work programme in July).

B. International protection

5. In July, the Standing Committee discussed the note on international protection; a paper on resettlement and complementary pathways, including an update on the implementation of the three-year resettlement strategy; an update on voluntary repatriation; and a paper on self-reliance and inclusion. It also received an oral update on the Executive Committee conclusions process and agreed to work on a multi-year workplan with possible topics for 2021-2022. The September Standing Committee received a further oral update on the Executive Committee conclusions process.

C. Regional activities and global programmes

6. UNHCR's operations in all seven regions (West and Central Africa; East and Horn of Africa and the Great Lakes; southern Africa; Asia and the Pacific; the Americas; Europe; and the Middle East and North Africa) were comprehensively discussed at the Standing Committee meeting in March. The Committee also received an oral update on global programmes. In July, an oral update on internal displacement was presented to the Committee, and a paper on emergency preparedness and response was discussed in September.

D. Programme/protection policy

7. In March, the Standing Committee considered a paper on UNHCR's programme in the United Nations: proposed framework for 2021, and received an oral update on the Global Compact

on Refugees and the outcomes of the Global Refugee Forum. At its next meeting in July, the Committee reviewed a report on UNHCR's global strategic priorities and discussed UNHCR's coordination efforts to measure the impact arising from hosting, protecting and assisting refugees.

E. Management, financial control, administrative oversight and human resources

8. In March, the Standing Committee received an oral update on the work of the Inspector General's Office.

9. In September, the Committee considered a report from the Board of Auditors on UNHCR's financial statements for the year 2019 and discussed the key issues identified in the report and measures taken by UNHCR in response, as well as follow-up to the recommendations of the Board of Auditors on financial statements for previous years. The United Nations Office of Internal Oversight Services (OIOS) presented its annual report on internal audit activities undertaken in UNHCR for the period 1 July 2019 to 30 June 2020, and the Independent Audit and Oversight Committee (IAOC) presented its annual report. An oral update was also provided on integrity in UNHCR, including efforts to prevent and respond to sexual exploitation and abuse, and sexual harassment. The Committee was further briefed on human resources, including staff welfare, and safety and security.

F. Coordination

10. In March, the Committee considered a report on strategic partnerships, including coordination, and in September, it received an update on the "grand bargain".

G. Governance

11. The Standing Committee adopted the work programme for 2020 in March, as proposed at its December 2019 planning meeting. The work programme was revised in July to reflect the addition of an item on UNHCR's new planning, budgeting and monitoring system. At its July meeting, the Committee was reminded that the High Commissioner's opening statement at the seventy-first annual plenary session of the Executive Committee in October would form the basis of the general debate, and delegations were invited to propose topics for inclusion.

III. Standing Committee decisions

12. In accordance with the authority vested in it by the Executive Committee, the Standing Committee adopted the following decisions, which are annexed to the reports of the Standing Committee meetings:
