

The Global Refugee Forum, pledge update – key figures I July 2021






PERCENTAGE OF 'FULFILLED' PLEDGES BY AREA OF FOCUS:

High-Level Officials Meeting

Purpose: To assess **progress and identify challenges, opportunities, and areas in need to support t**owards the objectives of the Global Compact on Refugees.

This assessment will be key to **charting the way forward**, including with a view to developing pledges for the next Global Refugee Forum.

The **GCR indicator report** as well as **analysis of pledge implementation and progress on GCR initiatives** will contribute to the evidence base needed to make this assessment, but this is only the beginning of a process.

More engagement by governments and other actors in building and strengthening data collection systems will be critical to developing a more comprehensive assessment of progress and needs.

WUNHCR Reflecting on progress and charting the future

Priorities areas for the High-Level Officials Meeting include:

- Expanding support for refugees and host countries:
 - broadened engagement of States, the private sector, and development actors, i.a.
 - strengthened and innovative approaches to partnerships and solidarity
 - national and regional arrangements (i.e. support platforms, CRRF, inter alia)
- Advancing implementation of pledges made at the first GRF:
 - implementation, including through an Age, Gender, Diversity lens
 - specification of global pledges towards specific refugee situations
 - matching of financial and policy pledges
- Identifying areas in need of further support:
 - further implementation of current pledges
 - development of new pledges for the next GRF
 - new partnerships and engaging new actors
 - strengthened engagement in refugee situations
