

Presence: The UN Refugee Agency has been working in Ukraine since 1994 and established a country office the following year. A host country agreement was signed in September 1996. UNHCR works to ensure the protection of and solutions for refugees and asylumseekers, stateless persons, persons with undetermined nationality, IDPs and conflict-affected persons. Strategy: UNHCR's work in Ukraine is guided by its Multi-Year, Multi-Partner Protection and Solutions Strategy, which sets forth UNHCR's plans for engagement in 2018-2022.

LATEST DEVELOPMENTS

At the time of updating this fact sheet, in light of the rapidly deteriorating situation and war in Ukraine, UNHCR is ramping up its response and capacity in Ukraine and neighbouring countries to provide urgent humanitarian assistance where possible, in coordination with the authorities, UN agencies, affected communities and other partners.

UNHCR is rolling out protection monitoring and providing basic assistance to some shelters hosting internally displaced persons. However, the security situation has made it extremely difficult to deliver assistance.

UNHCR declared a Level 3 Emergency for Ukraine on 25 February, and jointly launched with OCHA the Humanitarian Flash Appeal and the Regional Refugee Response Plan (RRP) for the Ukraine situation on 1 March.

STRENGTHENED PROTECTION FOR STATELESS PEOPLE IN UKRAINE

Asylum

- Protection: UNHCR monitors the situation of persons of concern and intervenes to ensure access to asylum procedures and protection for refugees.
- Asylum procedures: UNHCR works with the Government to enhance efficiency and fairness of the asylum system through capacity-building of authorities, judges, lawyers and border guards. UNHCR advocates for amendments to national asylum legislation to align it with international and European standards. In 2020, UNHCR published comments on the draft asylum law with recommendations on the right to work for asylumseekers and access to social protection. The draft law is pending first reading in Parliament.
- Durable solutions: UNHCR focuses on integration and self-reliance support, providing language training and grants for starting a business or attaining vocational education to refugees and asylumseekers. UNHCR also advocates for the establishment of certified State language courses.
- Promoting social cohesion: Since 2018, through its Community Support Initiatives programme, UNHCR assists refugee community initiatives and funds projects to promote peaceful coexistence. **UNHCR's Community-Based Protection Working** Group engages NGO partners and government counterparts at the central and regional levels.

IDPs and Conflict-Affected Population

- UNHCR advocates for positive changes in policies on IDP inclusion, birth registration, freedom of movement, access to pensions, compensation for destroyed or damaged property for IDPs and residents of NGCA, and access to housing options to enable IDPs to attain durable solutions.
- UNHCR shapes its response through protection monitoring and jointly with NGO partners supports

persons with particular vulnerabilities with legal assistance, protection counselling, psychosocial support, and cash and in-kind protection assistance.

- UNHCR capacitates IDPs to advocate for their rights and access services and durable solutions through community mobilization.
- In NGCA, UNHCR repairs individual homes damaged in the conflict, and leads the Protection and Shelter/Non-food Items (NFI) Clusters.

Statelessness

- Ukraine acceded to the 1954 and 1961 statelessness conventions in 2013. In June 2020, following years of UNHCR advocacy, the Government adopted a law introducing a Statelessness Determination Procedure, operational since May 2021.
- UNHCR and NGO partners identify and provide legal aid to persons with undetermined nationality and irregular stateless persons. UNHCR advocates with and builds the capacities of Ukrainian authorities to implement the #IBELONG Campaign.

Working with Partners

- UNHCR cooperates with the State Migration Service, the Ministry for Reintegration of the Temporarily Occupied Territories and other ministries. UNHCR facilitates, with OCHA, humanitarian convoys to eastern Ukraine and works with eight local NGOs.
- External engagement: UNHCR cooperates with recovery and development actors on gradual transition of responsibilities to national authorities.
