# **Report of the eighty-third meeting of the Standing Committee (8-10 March 2022)**

# I. Introduction

1. The Standing Committee of the Executive Committee of the High Commissioner's Programme (Executive Committee) held its eighty-third meeting at the International Conference Centre Geneva from 8 to 10 March 2022, with many delegations participating remotely due to the ongoing coronavirus disease (COVID-19) pandemic.

2. The Chairperson of the Executive Committee, Permanent Representative of Lebanon to the United Nations Office at Geneva, opened the eighty-third meeting of the Standing Committee. The First Vice-Chairperson of the Executive Committee, Permanent Representative of Djibouti to the United Nations Office at Geneva, and the Second Vice-Chairperson of the Executive Committee, Permanent Representative of Croatia to the United Nations Office at Geneva, assisted in the chairing of the meeting.

3. New requests for observer status were approved for the following States: the Central African Republic, El Salvador, Equatorial Guinea, Gabon, the Gambia, Liberia, Niger and Sierra Leone. Including those approved at the seventy-third session of the Executive Committee in October 2021<sup>1</sup> this brought the total number of Standing Committee observer States for the period October 2021-October 2022 to 16<sup>2</sup>.

# **II.** Representation

6. Other United Nations Member States present as Standing Committee observers were as follows:

Angola, Equatorial Guinea, Guatemala, Honduras, Indonesia, Iraq, Libya, Panama, Sierra Leone and Ukraine.

7. The European Union was represented as an observer. Also present were the following intergovernmental organizations and other entities:

International Development Law Organization and the Organisation of Islamic Cooperation.

8. The United Nations system, specialized agencies and related organizations were represented as follows:

Food and Agriculture Organization, United Nations Children's Fund, United, United Nations Office for the Coordination of Humanitarian Affairs, World Bank Group and The World Food Programme.

9. Nine non-governmental organizations were in attendance.

11. The 2022 work programme, as discussed at the planning meeting held in December 2021, contained in annex I was adopted as presented.

## IV. Work of the eighty-third meeting

12. The Deputy High Commissioner delivered an opening statement. The Assistant High Commissioner (Operations) then provided an overview of the challenges and opportunities facing UNHCR operations in the seven regions under its organizational structure and highlighted advances in key programmatic areas.

13. Presentations under each agenda item were made by senior management of UNHCR, and Executive Committee members and Standing Committee observers were given the opportunity to make comments and ask questions. ## V. Decisions of the Standing Committee of the Executive Committee of the High Commissioner's Programme

## A. Programme of the Office of the United Nations High Commissioner for Refugees (UNHCR) in the Secretary-General's proposed programme budget for 2023

### 14. The Standing Committee,

Takes note of part VI, section 25, programme 21: International protection, durable solutions and assistance to refugees of the United Nations proposed programme budget for 2023.

## B. Decision on budgets and funding for 2021 and 2022

#### 15. The Standing Committee,

*Recalling* the Executive Committee's decisions, at its seventieth and seventy-first sessions on administrative, financial and programme matters (A/AC.96/1198, para. 13(c) and A/AC.96/1209, para. 12(b)), as well as its discussions under the programme budgets and funding item at the eighty-second meeting of the Standing Committee in September 2021,

*Reaffirming* the importance of greater responsibility-sharing in solidarity with countries hosting refugees,

*Recalls* that the Executive Committee, at its seventieth session, approved original programmes and budgets for regional programmes, global programmes and headquarters under UNHCR's 2020-2021 biennial programme budget, amounting to \$8,667.7 million and \$8,615.8 million for 2020 and 2021, respectively,

*Recalls* that the Executive Committee, at its seventy-first session, approved revised programmes and budgets for regional programmes, global programmes and headquarters under UNHCR's 2020-2021 biennial programme budget (revised), amounting to \$9,131.3 million and \$8,615.8 million for 2020 and 2021 respectively,

*Notes* that the final 2021 supplementary budgets amounted to \$631.7 million for programmes benefiting UNHCR's global refugee programme, and projects for internally displaced persons,

*Takes note* of the increase in the annual budget of UNHCR for 2021 to a final total of \$9,247.6 million, representing the sum of the revised budget of \$8,615.8 million and the final supplementary budgets of \$631.7 million,

*Recalls* that the Executive Committee, at its seventy-second session in October 2021, approved original programmes and budgets for regional programmes, global programmes and headquarters under the 2022 annual programme budget for UNHCR, amounting to \$8,993.7 million (A/AC.96/1220, para. 13 (d)),

*Takes note* of the increase in UNHCR's annual budget for 2022 at a current total of \$9,287.2 million as at 31 January 2022, representing the sum of the original budget of \$8,993.7 million and the supplementary budgets of \$293.5 million,

*Recognizes* that emergencies and unforeseen activities unfolding in 2022 may result in the need for additional or expanded supplementary budgets and that additional resources, over and above those for existing budgets, would be needed to meet such needs, and

*Urges* member States to continue to respond generously, in the spirit of solidarity and in a timely manner, to the High Commissioner's appeal for resources to meet in full the annual budget for 2022.
