

### 2022 High Commissioner's Dialogue on Protection Challenges: Development Cooperation

### **Descriptions**

MIRPS National Coordination Group Meeting: Presenting Honduras' Action Plan

Regional Focus: Honduras

Date: September 29, 2022

Format: In-person in Tegucigalpa, Honduras

Description: The Government of Honduras (GoH) presents the update of its National Action Plan under MIRPS, which is composed of 26 commitments.

The roundtable aims to facilitate a space for regular dialogue between the GoH and representatives of G16 member countries and Support Platform countries to present the Government's work in responding to forced displacement, expand understanding across the Government,

donors and development actors on their respective areas of interest, and explore opportunities for joint work.

Regional Roundtable on Protection Challenges: West and Central Africa

Regional Focus: Sahel, Lac Chad Basin and CAR Situations

Date: October 25th, 2022

Format: Hybrid format with a physical location in Lomé, Togo

Description: The roundtable explores how development actors can capitalize on the momentum created by the Action Agenda on internal displacement

to advance durable solutions for refugees and IDPs in the region, discusses examples and ways to integrate displaced populations in national and local development plans, and explores collaborations with development partners to respond to the growing urbanization of

displacement.

High-Level Roundtable on Return and Reintegration of Burundi Refugees

Regional Focus: Burundi Situation

Date: October 30th - November 2nd, 2022

Format: Field mission to return areas with development partners and roundtable in Bujumbura, Burundi

Description: This roundtable aims to shore up support for reintegration efforts of returnees in Burundi. The roundtable highlights the large-scale recent

returns of refugees to Burundi and underscores the opportunities and challenges of refugee reintegration. The discussion explores with development partners ways of enhancing development cooperation in areas of return, including through strengthening and expanding basic

services and livelihoods opportunities to benefit Burundian returnees and their communities.

A People-Centered Approach to Preparedness and Responses in Climate Emergencies

Regional Focus: Mozambique

Date: November 2nd - November 4, 2022

Format: Field mission and roundtable in Nampula, Mozambique



Description: The Southern Africa Regional Roundtable focuses on the nexus between emergency preparedness and responses to climate-related

disasters, forced displacement and development in Mozambique. It aims to share experiences and lessons learned with other countries in the region facing similar challenges (e.g., Malawi, and Zimbabwe) and identify opportunities to broaden and deepen cooperation between

humanitarian and development actors, as well as host countries.

#### **Advancing Inclusion in MENA through Development Cooperation**

Regional Focus: Mauritania and Jordan Date: November 8th, 2022

Format: Virtual

Description: The virtual roundtable includes two sessions of moderated discussion looking at the role of development cooperation in facilitating inclusion

in national systems through shared experiences from Jordan and Mauritania. Bringing together key partners and experts from two different operational contexts where progress has been made in development cooperation, the roundtable aims to share learnings, identify challenges, opportunities and recommendations to strengthen partnerships with development actors and to inform development cooperation

in other displacement contexts in the region.

#### Regional Roundtable on the Afghanistan Situation

Regional Focus: Afghanistan and neighboring countries

Date: November 17th, 2022

Format: Virtual

Description: The Regional Roundtable will explore what the role of development cooperation in the Afghanistan situation can and cannot mean given

current circumstances and with regards to comprehensive approaches to solutions, conditions for sustainable return for refugees and IDPs, local solutions, and resettlement. Given the importance of maintaining continued protection space in the wider region, the multi-stakeholder discussion will also consider the need for sustained development support to neighboring countries which have generously hosted millions

of Afghans for decades.

# Refugee Inclusion in Moldova: Operationalizing the Temporary Protection Regime and Strengthening Prospects for Socio-economic Inclusion and Economic Growth

Regional focus: Moldova

Date: November 24th, 2022

Format: In-person in Chişinău, Moldova

Description: The roundtable consists of two sessions. The first focuses on the role of development actors for operationalizing the upcoming temporary

protection regime for refugees from Ukraine, with a particular emphasis on registration and the effective inclusion into national systems and services. The second session explores how development actors may capitalize on the increased interest on Moldova to support inclusive growth and access to decent work for refugees and host communities, considering the multiple crises (34% inflation rate, energy crisis with gas prices rising 600% within a year, value chain disruptions and reduced remittances) the country is facing and the need to strengthen the

role of the private sector and access to childcare.
