3. QUALIFICATIONS

- Minimum three years' experience providing photography and video services to major media outlets, government institutions and/or United Nations agencies
- Familiarity with UN programmes and humanitarian issues, including protection sensitivities.
- High level of creativity and initiative.
- Experience in recording and producing videos and documentaries (for videographers only).
- Ability to work with different teams and deliver to deadlines.
- The photographer should provide the technical equipment needed for the shooting and editing including cameras as well as any additional light equipment deemed necessary.
- Fluency in spoken and written English.
- Ability to provide coherent and accurate subtitles.
- Ability to manage multiple revisions at short notice (for videographers only).
- Ability to travel within Asia and the Pacific region on assignment when required.
- Experience in working with vulnerable people in humanitarian settings and shooting/filming in a de-identified manner is also desirable.
