1	I have more questions that alcohol based hand sanitizers would be alcohol hand gel or alcohol hand spray?	Either is acceptable.
2	Is this ITB open to all vendors from all nationalities	This tender is open to companies legally registered to operate in Thailand.
3	Can you please advise on what basis are we to offer our price, i.e. FOB/FCA, CIP, DAP etc.	EXW (ex-works). The seller will make the goods available at a delivery location in Bangkok metropolitan region and UNHCR will arrange for transportation.
4	Annex B seems to indicate that the prices must be submitted in THB but the ITB states that prices need to be submitted in USD; can you please confirm what the correct currency is for the submission.	Prospective sellers should submit their bids in Thai Baht (THB).
5	I want to know for this bid, can we supply the offer in USD?	Prospective sellers should submit their bids in Thai Baht (THB).
6	Do you want gel or liquid sanitizer?	Either is acceptable.
7	Scented or unscented	Either is acceptable.
8	Is there any labeling norms?	Products should comply with Thai (FDA) labelling regulations.
9	Is the price a constrain in placing the order?	Only the financial bids of those who pass the technical evaluation mark will be considered. Detailed technical requirements are included in Annex A. The tender will go to the lowest bidder amongst those who meet our technical requirements.
10	Any components restricted by customs or govt of Thailand.	Products should comply with applicable Thai FDA regulations.
11	Are these tenders opened for international bidder or local Thailand bidder?	This tender is open to companies legally registered to operate in Thailand.
12	In case open for the international bidder, can we make our quotation in the currency of the US dollar?	This tender is open to companies legally registered to operate in Thailand and Bids are expected in Thai Baht (THB)

13	At clause 2 of Annex A - transportation details indicate that UNHCR will arrange for transportation from the manufacturer's location, could you clarify where is this manufacturer's location defined? in case the manufacturer's location is in China, should we arrange the goods gathering in a place within Thailand?	The seller will make the goods available at a delivery location in the Bangkok metropolitan region. UNHCR will arrange for transportation.
14	Is FDA registration required for the product? Or is it sufficient for the product to be registered under a Ministry Of Health authority, i.e. the National Pharmaceutical Regulator Agency (NPRA) of Malaysia	Products should comply with applicable Thai FDA regulations and the tender is open to companies legally registered to operate in Thailand
15	Is it required for the company to be based in and legally registered in Thailand?	The tender is open to companies legally registered to operate in Thailand
