The Office of the United Nations High Commissioner for Refugees (UNHCR), established on December 14, 1950 by the United Nations General Assembly¹, requests your price quotation for provision of medical equipment and materials that is specified in ANNEX A 'Specification' in this Request for Quotation (RFQ).

1. REQUIREMENTS

- Detailed list of required items is provided in Annex A – Equipment specification;
- Quality/sanitary and other relevant certificates where applicable;
- Participant has to clearly indicate estimated delivery time in calendar days in Annex A. On UNHCR demand, Participant will have to provide works status report;
- The goods shall be supplied with sanitary certification and/or other certification proving its validity for use in hospital for medical process;
- Note that Annex A is attached to a separate Excel file. Each bidder may submit bids separately for each lot item;
- Provided goods are subject to minimum 1 year warranty;
- Signed Annex B, UNHCR General Conditions of Contracts;
- Signed Annex C, Vendor Registration Form;

Please include the following information in your quote (without VAT):

- Item price, item total cost;
- Currency: UAH;

Please note that UNHCR has tax and duty exemption status. Shipping documents formalization order is provided in Annex D.


