1. REQUIREMENTS

Description: **INSTALLATION OF ONE (01) PREFABRICATED UNIT**

Please use Annex B (Financial Offer Form) for provision of your quotation. The Financial Offer Form should be duly signed and provided as indicated in **Clause 2 - RFQ Submission** below.

Please note that UNHCR has tax and duty exemption status, therefore please provide your quotation without VAT.

To be considered qualified for financial evaluation, your company should:

1. Provide duly filled and signed Vendor Registration Form (Annex E)
2. Duly be a registered and operational company
3. Have the ability to pre-finance the project
4. Provide valid licenses to conduct requested construction works
5. Be able to complete the construction works for **LOT 1** within 21 days, for **LOT 2** within 14 days, for **LOT 3** within 14 days.
6. Provide a warranty period of 12 months to cover defects after completion and handover of the project.
7. Provide UNHCR with technical reports upon completion of the project
