This license allows administrators to configure networks, manage installation or access to applications, configure individual user access, and maintain and manage the status of each device. This license is a requirement for managing your Chrome devices through Google domain.

Obtaining Google's authorization to deliver to Ukraine:

Chromebooks and the CEU are not standard for commercial sale and distribution in Ukraine, therefore bidder is to obtain an exception from Google for sales and delivery to Ukraine. Such authorization must be attached to the bid.
